In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. **Generic**

The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. 1. The amount of rates of minimum wages are based on the latest order of Haryana Koshal Rojgar Nigam Limited. Bid offering prices which are lower than the minimum wages (as applicable to Haryana Koshal Rojgar Nigam Limited) would be rejected.
2. Service provider who are having Head office/ Main office located in Panchkula/Chandigarh. The service provider should attach copy of documents in support of his claim.
3. The service Provider Company is required to pay Salaries/wages of outsourcing staff deployed at the buyer location first i.e. on their own and then claim payment from buyer along with all statutory documents like PF, ESIC etc. Evidence regarding deposit of PF/ESI and other statutory payments to the Govt. A

ccount is to furnished every following month.

4. The service Provider Company /firm /agency must exist on the records of Income Tax and GST department. The service provider is required to attach ITR / GST Return for the financial year 2022-23, 2023-24 and 2024-25.
5. The service provider should not have been involved in any malpractices.
6. Any contractor who has been issued any notice/Memo/ unsatisfactory service by the first party in past years would not be considered and would be rejected.
7. The service provider should be having annual turnover not less than 25 Lakh in each proceeding's year in last four years i.e . FY 2021-22, 2022-23, 2023-24 & 2024-25.
8. The service provider should have experience of Manpower service for the at least 5 years in government department. Service provider with experience of less than 5 years in government department would not be considered. Kindly provide three acknowledgments issued from the concerned department to whom services had been provided in support of your claim.
9. Educational qualification of outsourced staff should be as per Haryana Koshal Rojgar Nigam Limited recommendations/ order.
10. No. of outsourced staff may be increased / decreased as per sanction / instructions issued from time to time by the competent authority.
11. Successful bidder will have to provide police verification certificate with regard to all the deployed outsourced staff.

12. Successful bidder will have to issue the identity card to all the deployed outsourced staff under intimation to this office and provide the proper uniform / Clothes to all the deployed outsourced staff for security (Uniform only for security guards)
13. Successful bidder will have to abide by all the government policies and directions if any, issued time to time.
14. Successful bidder will be required to retain existing /old outsourced staff deployed with this office.
15. This office reserves the right to amend/withdraw any of the terms and conditions or to reject any or all tenders/bidders without giving any notice or assigning any reason. The decision of the First Party in this regard shall be final and binding on all after approval from the higher authority.
16. All the service providers are mandatory required to fill the following proforma. Any application received for the bid without complete information in given proforma would be rejected.
17. If any dispute arise in respect of outsource staff the bidder is solely responsible to sort out the matter. Buyer is not liable for any legal issue.
18. The bid / bidder is liable to be rejected for any incomplete information (NOT FULLY FILLED PROFORMA)

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
