1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Stipulations of GCC services and GeM conditions are applicable in this bid document .If there is any contradiction between tender( bid) document and GCC services & GeM conditions, then tender document E-Tender No.[NWR-JP0EnHM\(CLEA\)/4/2025-O/o DEnHM/JP/NWR](#) shall have precedence over the GCC and GeM conditions.

2. Minimum eligibility criteria including turnover and other criteria etc stipulated in the tender document shall be applicable.

3. As stipulated in tender document ,bidders can submit the EMD Rs 88,100/- with Account Payee Demand Draft /Banker cheque/FDR or bank Guarantee stipulated in GeM GTC in favour of FA and CAO North Western Railway Jaipur payable at Jaipur. Bidder has to upload scanned copy / proof of the EMD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 working days of Bid End date / Bid Opening date . Tender security (Earnest Money) is waived off for those who are registered with Micro & Small Enterprises (MSEs) and registered for appropriate category .The Bidder must submit documentary evidence for the same.

4. As stipulated in tender document, In terms of para 4.11 of GCC services and Railway board letter 2017/E

nHM/25/11 dated 24.05.2024 circulated vide NWR-HQ0MECH(EnHM)11/2020/6158 dated 28.05.2024, performance guarantee at a rate of 5% of the contractual value shall be deposited by the successful bidder.

5. The pest control operation should at no time violate the provisions of the Insecticides Act, 1968 and Insecticides Rules 1971 and/or any other relevant Law and Rules as framed by Government of India, State Government or Local Bodies. The pest control operations shall be done only by agencies, which have been approved by the Plant Protection Officers of the concerned state's agriculture department or Central Insecticides Board and Registration Committee (CIB&RC), Faridabad. The PPOs are available at the district/division level. The pest control operators/agencies should provide an attested copy of their license in the prescribed form with clear endorsement for permission to carry out commercial and domestic pest control. The license should not be only for selling, exhibiting and stocking insecticides. Their license should be valid for the entire duration of their contract with Railways. Non submission of copy of the license by the bidder shall result in summary rejection of his/their bid.

6. The tenderers shall submit declaration as given in Annexure-A1. Non submission of the same by the bidder shall result in summary rejection of his/their bid. And it shall be mandatorily incumbent upon the tenderer to identify state and submit the supporting documents duly self-attested by which they/he is qualifying the Qualifying Criteria mentioned in the Tender Document. It will not be obligatory on the part of Tender Committee to scrutinize beyond the submitted document of tenderer as far as his qualification for the tender is concerned.

7. The tenderer must submit an undertaking as per Annexure-B1. Non submission of this undertaking by the bidder shall result in summary rejection of his/ her bid.
