1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

A) Technical specifications

Item no 1. HDPE Woven Bags (Box Type)

Quantity: 30,000 EA

1. Inner Dimensions of the Bag: 700 mm (Length) X 610 mm (Width) X 320 mm (Height)

2. The HDPE bag should be made of three layered packing material as mentioned below:

- a) First outer layer is of 10 X 10 mm mesh HDPE fabric.
- b) Second layer is of 50 micron LDPE lamination grade conforming to Virgin Plastic.
- c) Third layer is of sack craft paper of 100 GSM having burst factor of 25.
- d) The GSM of HDPE bag should be 200 ± 20 GSM.

3. There should be good bonding of craft paper and HDPE material.

4. The dimension of flap should be 40 mm more to overlap on both the top covers length wise as well as width wise so that the sealing can be done easily with the HDPE adhesive tape.

5. The joints and edges of the HDPE packing material shall be firmly stitched with good quality nyl on equivalent thread. The bags should be stitched on Industrial Stitching Machines only.

6. Then the joints and edges to be bonded together with self-adhesive good quality BOPP/PVC tape in Black / Blue colour.

7. HDPE self-adhesive tape 50 mm width should be supplied by the supplier along with the bags at the rate of 1.0 meter per bag in roll form.

8. Overall stiffness of HDPE bags should be good so that when placed in the wooden box the bag s hould retain the box dimension and should not get de- shaped.

The Quality Control requirement is as follows:

1. The firm should furnish a Test Report from the NABL accredited lab along with each and every lot supplied.
2. The supplier should follow the plastic regulatory rules framed by Govt. of India and Govt. of Maharashtra in vogue at the time of supply of material.
3. HDPE Woven bags rejected due to sub-standard material, faulty fabrication, etc. shall be replaced by the supplier at his own cost.

Warranty: The warranty period of Six (06) Months from the date of issue of suitability.

Delivery Schedule: Firm should supply 5000 bags within 40 days of order. Remaining installmen

ts should supplied only after suitability of first supply.

B) MINIMUM ELIGIBILITY CRITERIA

The following shall be the minimum eligibility criteria for selection of bidders:

1. Capability - Equipment & Manufacturing Facilities:

The bidder firm should have capability to manufacture and supply of HDPE Woven Bags.

2. The bidder should give undertaking/declaration that they have read and understood all the terms (with technical specification, GIT & GCC) & conditions of tender documents and submitting unconditional acceptance to all terms & conditions.

3. The bidder should give a declaration that they have not been black-listed/ debarred for dealing by Government of India in the past.

4. The bidder should submit Power of Attorney of the Authorized Signatory for signing the bid, entering into contract, if awarded and for any other correspondences.

5. The bidders shall enclose copy of GST Registration Certificate (in REG-06 format) & copy of PAN Card.

6. The bidder should give undertaking/declaration that they have read and accept the Technical Specifications mentioned in the tender documents.

7. The bidder should give undertaking/declaration that they have read and accept the delivery schedule mentioned in the tender documents.

8. Note:-

(i) In support of experience criteria, the bidder has to submit attested copies of P.O's, Experience certificates issued by customers.

(ii) All experience, past performance & capacity/ capability related/data should be certified by the authorized signatory of the bidder firm. The credentials regarding experience and past performance to the extent required as per eligibility criteria submitted by bidder may be verified from the parties for whom work has been done.

1. "The specifications indicated in the bid are essential requirements. However, sellers are free to

bid for same or superior specifications. Buyer will evaluate such bids based on their requirements / end use and bid parameters and will accordingly technically accept or reject the bids on merits."
