1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.

6. Sample Clause

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

2 samples for Buyer's approval, within 5 days of award of contract. Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 5 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller. Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.

Additional Terms & Conditions

1. OEM must submit Valid Certificates: ISO 9001,14001, FCC, CE/CB test report.
2. OEM Headset must Certified with EN 50332-2 .
3. OEM presence in India for more than 20 years or above documentary evidence for the same to be provided along with the offer otherwise offer will be summarily rejected.
4. The OEM mandate to provide bid-specific Manufacturer Authorization Form (MAF) on the OEM's letterhead mentioning the bid number and signed by an authorized representative.
5. For better service to end customer OEM should have minimum 40 or more authorized service centre in India and minimum 1 in Delhi.
6. OEM must submit the declaration that OEM for the system should provide software free of cost for the integration of the system in any workflow / Application.
7. OEM must submit the declaration that offered/quoted Product must have Dual noise-cancelling microphones (ANC).
8. Datasheet, Technical Compliance to be submitted on OEM letterhead duly signed and stamped by the authorised signatory. (Any deviation led to disqualification)
9. As a part of Technical Evaluation of Bids, department may ask for live demonstration of quoted product, The bidders will be intimated the exact date and time slot for them to carry out such demonstration. An undertaking to this effect be attached with the technical bid by the bidders that the firm is ready to live demonstrate their quoted equipment/item (Un-satisfactory performance may led to disqualification)
