1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery

time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Buyer Added text based ATC clauses

1. Offers from the manufacturers empanelled in DSP's existing Bearing Policy under category 1 shall be considered for evaluation. Offer from any other manufacturer shall not be considered for evaluation and shall be rejected.

2. In case authorised dealers/distributors submit offer, they have to submit Bid specific authorisation from the manufacturer of the offered product along with their offer, otherwise their offer shall be rejected.

3. In case both manufacturer and their authorised dealer/distributor submit offer, the offer of the manufacturer shall be accepted for evaluation. Offer of the authorised dealer/distributor shall not be considered for evaluation.

4. Payment term:

a) 80% of basic price + 100% GST will be released against GRN.

b) 20% of the basic price shall be released on prorata basis (i.e. number of bearings installed), based on successful installation and production of 50,000 T of MSM product with the same bearing.

5. Delivery:

Supply of first lot of Bearings should commence within six (6) months from the date of PO placement. The contract period shall be one year from the date of placement of PO. However, the same can be extended or prepone by the Executing Authority (EA) as per the actual site condition. Offers with delivery schedule not in compliance with the delivery period mentioned in Bid may be liable for rejection.

6. Bulk packing is not acceptable. Individual packing of each bearing is required.

7. Bearings are to be sealed & certified by the manufacturer's representative before despatch & certificate is to be sent along with the supplies.

8. In case of offer submitted by authorised tenderer of indigenous Manufacturers or those of Indian subsidiaries for overseas manufacturers, Bill-to-dealer Ship-to purchaser basis shall be the preferred modality.

9. Undertaking attached with Bid to be accepted with sign & seal in your company's Letterhead and to be attached with your offer.

Risk Purchase: If the Supplier fails to deliver the stores either in full or in part, within the prescribed delivery period, the Purchaser shall be entitled at his option to take alternate procurement action, at the risk & cost of the supplier for the unsupplied portion of the goods / items for which delivery has expired without cancelling the contract in respect of the stores not yet due for delivery, or to cancel the contract based on progress of work, including stores not due for delivery, and, if thought fit/necessary, to purchase the stores at the risk and cost of the Supplier. The price differential in case of higher cost to SAIL, if any, shall have to be borne by the defaulting supplier. Moreover, the defaulting supplier shall have no claim over the quantity, which they failed to supply.

Special terms & Conditions:

1. This bid is for supply and apply of bearing. Party has to supply the material and to carry out the application which includes Inspection, Mounting, Dismounting, Clearance measurement & Bearing wise Record keeping

ping as per direction of the EA of MSM Department.

2. Scope of the contract includes inspection of chock and bearings at MSM site, supply of the bearings specified in the tender and supervision by supplier's engineers during fitment of bearings / assemblies, along with the following.

a) Within 15 days of order placement, an inspection schedule shall be jointly prepared by EA (Executing Authority) and supplier's engineer. Supplier's engineer will visit site to carry out inspection of roll neck & chock conditions as per the schedule or as and when required and for changing of the bearings. Prior information will be provided by EA to the supplier.

b) Based on inspection report, delivery schedule shall be jointly prepared and material is to be delivered as per mutually agreed plan.

c) Progressive installation programme of bearings will be intimated by MSM/DSP. For each instance of installation, intimation shall be sent through e-mail, by MSM/DSP to the supplier, 7 days prior to actual installation date and accordingly supplier will send engineers for supervision & monitoring. All check-List & records related to bearing inspection/changing will be maintained by supplier & to be shared with MSM/DSP.

d) All the tools & tackles as well as manpower for the bearing changing job will be provided by MSM/DSP, However, special tools and tackles (if required) are to be brought by the supplier/party at its own cost.

e) Spare components required for bearing installation shall be provided by MSM/DSP.

f) Installation report shall be provided by the supplier to EA after every assembly within one week of installation.

g) Roll neck/Chock condition assessment report shall be provided monthly by the supplier.

h) The supplier shall submit quarterly activity report to MSM/DSP.

i) The supplier's engineer shall impart training to the MSM team on the Mounting/ Dismounting & Maintenance of Roll Neck Bearing" topic once in quarter during contract period.
