1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

1. Generic

After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing- the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar

proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. **Scope of Supply**

Scope of Supply - Only Supply with 2 year warranty.

4. **Mandatory Certificates:**

To be eligible for the award of the contract, the bidder must possess a Character Certificate and a Solvency Certificate duly issued by the District Magistrate and Labour Certificate - Minimum 10 Labour Requirement (Uttar Pradesh). The same are enclosed here with for your kind perusal and necessary action. These certificates have been obtained from the competent authority and are valid as per the prescribed norms.

5. **Turnover**

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support: BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

7. **Forms of EMD and PBG**

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C **Executive Officer Nagar Panchayat Jahanabad Pilibhit**. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date.

8. **Service & Support**

Escalation Matrix for Service Support: Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

9. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

10. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

11. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centers near consignee destinations are to be uploaded along with the bid. (It is mandatory to upload the required certificate)

12. All bid documents along with the EMD of mentioned in the bid (submission compulsory for all bidders with no exemption for MSME/Startups), which are uploaded while participating in the bid, must also be physically submitted to the Buyer's office within 5 days of the Bid End Date/Bid Opening Date.

13. Bidders require to submit PAN card, GST certificate with Current GST Return, Adhar Card along with the documents.

14. Any gazetted officer who is/was working in an administrative department of the State Government or the

Central Government shall be prohibited from undertaking contractual work for a period of two years after retirement without prior permission of the Government. If it is found that the contractor or his representative has not obtained prior permission from the State Government before submitting the bid, or has started working with the bidder, the contract may be cancelled.

15. Any bidder shall not be eligible to participate if, in the concerned division/range where the work is to be executed, the bidder himself/herself or any of his/her close relatives (first blood relation or spouse) is working as a Nagar Panchayat Jahanabad Pilibhit, The bidder shall also submit an affidavit on ₹10/- stamp paper declaring the names and designations of his/her relatives who are working in the concerned department and/or related division/range.
16. Successful bidder has to get advance approval of the sample or diagram from the office, before final supply of items.
17. The material shall be supplied on or before 30-08-2025 from the date of issuance of the work order.
18. Payment will be made only when the quality of the material supplied as per the work order is as per the standards of the department.
19. If for any reason the dates mentioned in the tender notice happen to be a holiday, the tender will be opened on the next working day.
20. As per above, the material has been estimated in relation to the physical target allotted to the division, the quantity of material may increase or decrease depending on the budget availability, for which no claim of the bidder will be accepted.
21. If the firm/company is a partnership then it will be mandatory for all the individuals to upload Aadhar Card, PAN Card and Partnership Deed.
22. The undersigned reserves the right to reject any or all the bids without assigning any reason.
23. The Buyer will verify all documents submitted by the participating reseller company, and if any document is found illegal the bidder will be blacklisted and/or face legal action; it is mandatory to upload a ₹100 notarized and attested Declaration of Non-Blacklisting, No Criminal Record, and Not Being Registered with the Bar Council, and the bidder also declares having good reputation and conduct in the Nagar Panchayat Jahanabad and other Department (Bid Effective Date).
24. It will be mandatory for the company/firm/individual firm to attach the certificate to give the name of the firm, Current Place of the office, mobile Number and account Holder bank Details.
25. Supply Experience - The bidder should have experience in supplying. In respect of supply of any one order within the last five financial years. Which is 50% of the estimated cost of the bid.
26. To be eligible for award of contract, bidder must possess following certificates uploaded with bid document Quality Management System Certificate, Environmental management systems Certificate and MSME registration.
27. the bidder shall have to confirmed that bid over all conditions is acceptance must be uploaded on Letterhead and the bidder has to delivery of hardcopy to the buyer within 5 days of bid end date / bid opening date.
28. Net Worth of the Bidder should be positive as per the last audited financial statement.
29. To be eligible for award of contract, bidder must possess following certificates uploaded with bid document, 2024-25 Balance sheet and Profit & Loss and 2025-26 ITR Return.
30. Queries or objections may be submitted only within the bid date and the prescribed time period. Any complaint received after the closure of the bid or at the time of bid opening shall not be considered.

***Note*- If the bidder does not upload any documents or unreadable or unclear scanned, then he will be disqualified.**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
