2. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. **Buyer Added Bid Specific Scope Of Work(SOW)**

Scope of Work and Additional Terms & Conditions

1. MSE Exemption

MSE exemption for years of experience and turnover will only be provided to enterprises registered with the Ministry of Micro, Small and Medium Enterprises, Government of India, under the following category:
(A) 7100 — Architectural and Engineering Activities and Related Technical Consultancy

2. Definition of Similar Services

“Similar Services” refers to services involving the deployment of manpower for activities such as:

- Digitization / Feature Extraction
- Data Processing
- Familiarization with ArcGIS Software
- Aerial Survey Data Processing Software, etc.

3. Eligibility Criteria for Manpower

(a) Age: 21 to 50 years

(b) Educational Qualification: Graduate/Diploma in any discipline of Engineering/Science/Commerce/Arts etc

(c) Experience:

- For B.Tech/B.Sc: Minimum 6 months in Similar Services as defined in Para 2
- For Diploma: Minimum 1 year in Similar Services as defined in Para 2

4. Key Responsibilities of Deployed Manpower

(i) Perform digitization, feature extraction, and image processing using drone-captured images at GD&D G DC, Survey of India, Gandhinagar (Gujarat) under the supervision of the Section Officer.

(ii) Conduct Quality Assurance/Quality Control (QA/QC) of digital data as per the SOP provided by SOI.

(iii) Perform attribute data entry using GIS software.

(iv) Participate in training sessions and self-learning activities for all the above tasks as per SOI guidance.

(v) Adhere to conduct rules and maintain office discipline as per government norms.

(vi) Provide any other assistance required for the execution of GIS work.

5. Office Setup Requirement

After award of the bid, if the bidder does not already have an office in the state of the consignee, it must be established mandatorily.

6. Shift Timings

Manpower may be assigned to any of the following shifts as per workload and management requirements:

- 06:00 hrs to 14:00 hrs

- 22:00 hrs to 06:00 hrs

7. Variation in Manpower Requirement

The service provider may be required to increase or decrease the number of deployed personnel with one (1) month notice from the purchaser.

8. Communication & Support

The service provider must provide a dedicated/toll-free telephone number, an email ID, and an escalation matrix for immediate service support after award of the contract.

9. Technical Evaluation

Technical evaluation of bids will be based on compliance with all requisite documents and conditions outlined in the bid inquiry and this Scope of Work.

10. Data Confidentiality

The service provider must submit an undertaking confirming that no data generated during feature extraction or related processes will be retained or reproduced. Violation of this condition shall invite penal action as per applicable laws.

11. Safety Responsibility

The service provider shall be fully responsible for ensuring all necessary safety precautions and compliance with applicable safety standards.

12. Regulatory Knowledge

The deployed technical manpower (Digitizer) must be familiar with all relevant Government of India rules and regulations, and ensure adherence to the same.

13. Character & Antecedent Verification

The bidder is responsible for verifying the character and antecedents of each employee. A police verification report, not older than three (3) months, must be submitted before deployment.

14. Compliance with Labour Laws

Financial bids which do not adhere to minimum wage laws prescribed by the Ministry of Labour & Employment will be summarily rejected.

15. Force Majeure (FM) Clause

Force Majeure refers to unforeseen and extraordinary circumstances beyond human control, including but not limited to Acts of God (natural calamities), war, strike, riot, or crime (excluding negligence, predictable events, or seasonal rain).

- Both parties shall be free from their contractual obligations during the continuance of such events.
- The affected party must notify the other as soon as the FM event occurs; ex-post-facto claims will not be accepted.
- If the FM event continues for more than 90 days, either party may terminate the contract without financial liability.
- Unless superseded by a specific Central Government order, this clause shall be binding on both parties (purchaser and supplier).

6. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

7. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

8. Service & Support

The Service Provider is required to have at least 30 % of the required manpower on service provider's

payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

9. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

10. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
