2. It will be no objection taken from any bidder for this tender for qualify and disqualify to any bidder. EMD exemption will be allowed as per Madhya Pradesh Store Purchase Rules and MSME guidelines; the bidder shall be liable for any false or misleading documents.

OEMs intending to avail MSME benefits for emd exemption shall submit an undertaking on their official letterhead along with valid proof of manufacturing activity such as factory registration, lease or ownership deed & recent electricity bill of manufacturing plant for verification and consideration by the department.

OEM must submit Manufacturing Facilities in plant with Quality Control Facilities with manufacturing capacity & process flow chart submit undertaking on company letter head.

The bidder shall submit an undertaking on their official letterhead stating that the rates quoted in the bid are strictly as per the item list attached with the tender, and that the supply of materials will also be carried out in full accordance with the same list. The supplied materials will be verified by the verification committee on the basis of the samples provided.

Bidder needs to upload declaration of GST of product as per revised rules.

All products and accessories should be of reputed brands. In case the quality of the product is bad & poor, the entire material will be rejected and the full responsibility will be on the bidder. Undertaking must be submit by bidder in ATC. If the quality of the supplied materials does not meet the prescribed standards, the firm will be blacklisted after returning the security deposit.

Prices shall be inclusive of all temporary permits, freight, insurance and all such other costs. Prices shall remain firm and no escalation shall be permissible. All statutory taxes and duties as applicable, within India shall be paid by the Supplier.
