1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the

Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

[OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

(III) Provision for PREFERENCE TO MAKE IN INDIA

Provision of the order No.P-45021/2/2017-PP(BE-II) dtd. 04.06.2020 issued with Revised 'Public procurement (Preference to Make in India), Order 2017' dated 16.09.2020 and as amended from time to time and its subsequent Orders/Notifications issued shall be applicable for this tender towards purchase preference.

The 'Class-I local supplier'/ 'Class II-local supplier' as per this provision at the time of tender, bidding or solicitation shall indicate percentage of local content and provide self-certification that the item offered meets the local content requirement for 'Class-I local supplier'/ 'Class II-local supplier', as the case may be. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Bidders shall also give details of the location(s) at which the local value addition is made. Declaration to be given in the format given in the Annexure II as attached under "Buyer uploaded ATC document" of this bid. **Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate.**

(IV) **Integrity declaration:** Bidder shall submit the completely filled Integrity declaration provided with the tender (without any alteration to the format) at Annexure- III along with the offer (Format attached in Buyer uploaded ATC document)

(V).INCOME TAX CLAUSE TO BID:

(i) For Supply Contracts / Purchase Orders / Supply portion of LSTK

NALCO being buyer (under section 194Q inserted in the Income Tax Act, 1961 vide Finance Act 2021) having total sales, gross receipts, or turnover from business above Rupees Ten Crores during the last Financial year, will deduct TDS under section 194Q, w.e.f. 01.07.2021, at the prescribed rate of 0.1% on the purchase value of any goods, aggregate of which is exceeding the threshold limit of RS. 50 Lakhs in a Financial year.

Accordingly, Vendors/sellers are not to collect tax at source under section 206C(1H) of the act w.e.f. 01.07.2021, in case provisions of section are applicable to them.

The above is as per the current statute and is subject to modification(s) based on amendments / notifications under Income Tax Act, 1961, from time to time.

(ii) For Other Contracts / Orders

Income Tax TDS, as applicable at the prevailing rate on the gross amount billed shall be deducted from the contractor's bills.

(VI). Detailed terms of scope of SUPPLY, FITMENT GUARANTEE, TEST, CPBG, DELIVERY SCHEDULE, etc. is as per the per custom catalogue (Technical specification sheet attached under "specification document" of the bid) and tender document of the bid. Hence bidders are requested to quote accordingly.

Ø Bidder shall upload the technical compliance sheets (custom catalogues under buyer specification document of gem bid) with duly signed declaration towards confirmation of the technical specification for the item of the bid confirming all points, failing which your offer may be liable for rejection.

Ø Bidder shall submit the complete Tender documents duly signed towards acceptance to tender's terms & conditions.

(VII). Other detail conditions as below shall be confirmed

- (a) Guarantee: The materials must conform to the specified requirements to ensure satisfactory performance under normal conditions. They shall carry a guarantee covering any issues arising from faulty design, incorrect specifications, defective materials, or poor workmanship for a period of 12 months from the date of commissioning or 18 months from the dispatch date, whichever is earlier.
- (b) A certificate from an Govt. approved laboratory must be submitted. Materials without this certification will not be accepted.
- (c) Fitment Guarantee: The supplier must provide a fitment guarantee ensuring compatibility with the existing system.
- (d) Initially, The vendor must first supply 3 No's samples for Testing of fitment and Quality. If these meet specifications and perform well upon inspection and installation, bulk supply will be approved.
Note: Samples will be tested only once; no replacements will be allowed.
- (e) Inspection: The material received will be inspected at our Central store and result shall be binding.
- (f) Packaging: Environment-friendly Weather proof packaging as suitable for the items capable of withstanding rough handling during transportation.

(VIII) Offers from the bidders who have failed to execute earlier orders/contracts or in list of Black-listed/suspended/banned vendors by Nalco will not be considered and not be acceptable.

(IX)-(A) DELIVERY AND PRICE REDUCTION SCHEDULE / LIQUIDATED DAMAGES: Delivery period is the essence of the contract and the materials should be dispatched within this time, failing which, NALCO without prejudice to its rights under the contract shall have the option either to reduce the price @1/2% of order value per week or part thereof subject to a maximum of 5% of the undelivered portion/the order value (if the item(s) cannot be used unless full supply is made) or to cancel the Order and purchase the materials from alternative source at the risk and cost of the supplier.

(B) The bidder should submit a bid only if the tender terms and conditions are acceptable. Any commercial term mentioned or submitted vide any attachments shall be ignored

(C) In case of any conflict between terms & conditions of GeM portal and against this tender, the terms & conditions in this tender shall prevail.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
