If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of

contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Firm must have experience of supply of Health care staff to any Govt. or semi Govt. or PSU section/hospital with 150 beds or more, in the last three years

2. The firm must have valid/updated MSME certificate for Human resource & human health activities & employment placement activities.

3. The tenderer must have successfully completed, any one of the following categories of work(s) during last 07 (seven) Financial years ending last day of month previous to the one in which tender is invited:

- i. Three similar service contract each costing not less than the amount equal to 35% of advertised value of the tender.
- ii. Two similar works each costing not less than the amount equal to 50% of advertised value of the tender, or
- iii. One similar work costing not less than the amount equal to 80% of advertised value of the tender. "

4. Financial Standing: The Bidders will be qualified only if they have minimum financial capabilities as below-

(i) T1- Financial Turnover: The bidder should have an aggregate financial turnover not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year up to the date of opening tender. The audited balance sheet reflecting financial turnover certified by chartered accountant with her stamp, signature and membership number shall only be considered.

(ii) T2-Liquidity : The bidder should have access to or has available liquid assets, lines of credit and other financial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's commitments for other contracts. The audited balance sheet and/or banking reference certified by chartered accountant with her stamp, signature and membership number shall be submitted by the bidder along with bid,

5. Availability of the office of Service provider : The Registered Head Office of the service provider must be located in the state of the consignee i.e., in West Bengal. The tenderer shall have a registered head office in the State of West Bengal. Document proof of registration certificate issued by the concerned authority clearly depicting the firm's Head Office in west Bengal State shall be submitted along with the tender **without which their tender will be summarily rejected.**

6. Attendance in Pre-Bid conference will be mandatory. Willing bidder/authorized representative of the bidder must attend pre bid conference to understand the nature of the job. Certificate of attendance will be issued after attending the pre bid conference. The certificate must be uploaded along with bid, otherwise tender will be summarily rejected. Each firm should nominate his own individual representative to attend the pre bid conference with valid and proper authorization and id- card. One person will be accepted as an authorized representative of one firm only.

7. Railway administration reserves the right to make direct payment to the engaged workers.

8. If there is non-performance/bad workmanship/non-satisfactory work, contractor will be served with 7 days' notice to make good. On expiry of 7 days notice, if contractor fails to make good or performance does not improve, then Railways have the liberty to issue 48 hours' notice of termination. On expiry of 48 hours notice period, contract would be terminated by issuing a letter and on such termination, contractor's entire Security Deposit available with Railways plus any dues arising from the works executed by the

contractor will be forfeited.

9.Documentary proof regarding payment of PPF of both employer & employee portion should be submitted every month after collecting the same from EPFO same is applicable for ESI also.

Suitability of the candidate :

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
