1. 2. 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

2. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. The Outsourcing agency has to replace the staff within 2 days if any hired staff resigns.
5. The hired staff have to work on holidays also if required.
6. The actual starting of the project work will intimate you after finalization of the bid.
7. The work tenure is 18 month and it will be extend or decrease.
8. If any problem arises while working tenure of the project, the authorities decision should be obey without any condition.
