7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 1. General Acceptance. Participation in the bidding process shall be deemed as unconditional acceptance of all terms and conditions mentioned herein, without any modification or reservation.

2. Status, Control and Responsibility of Personnel

2.1 All personnel deployed under this contract shall remain employees of the Contractor at all times. Under no circumstances shall they be treated, regarded, or deemed as employees of the Indian Coast Guard.

2.2 The Contractor shall be solely responsible for recruitment, wages, benefits, service conditions, discipline, conduct, and statutory compliances of all personnel deployed.

2.3 The Indian Coast Guard shall exercise only supervisory and coordinating control over the deployed personnel for performance of assigned duties.

2.4 In the event of failure by the Contractor to provide the required services, the Customer shall have the right to obtain such services from a third party at the Contractor's risk and cost, or deduct proportionate amounts from payments due.

Deployment, Conduct and Replacement

3.1 Personnel deployed shall be a adequately trained, disciplined, courteous, medically fit, and well-behaved, and shall carry valid company-issued photo identity cards while on duty.

3.2 All personnel shall be Indian nationals only and shall be deployed only after verification of character and antecedents by police authorities. Verification confirmation shall be submitted before or within 30 days after deployment.

3.3 The Contractor shall be fully responsible for the conduct, discipline, and integrity of deployed personnel. CGDHQ-3 reserves the right to demand removal of any personnel found incompetent, negligent, indisciplined, or involved in misconduct. Such personnel shall not be redeployed without prior approval.

3.4 In case of removal or resignation of any personnel, the Contractor shall provide a suitable replacement within 10 days. Failure to do so shall entitle the Customer to arrange a substitute at the Contractor's risk and cost.

3.5 Personnel shall normally be retained for the entire contract period. Frequent turnover or short-term deployment shall not be permitted. Any resignation shall require one month's advance notice.

4. Working Hours and Attendance

4.1 Working hours shall be 8 hours per day or as decided by the Headquarters at New Mangalore.
