1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

2. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

Participating Vendors must meet and accept following terms and conditions for being qualified in technical evaluation

1. The firm should have and upload following registration certificates on mandatory basis : (i) MSME (ii) GST (iii) Labour registration (iv) EPF (v) ESIC
2. Office of the firm should be in Dehradun as per all the registration certificates mentioned at para 1 above.
3. Labour registration certificate provided by Uttarakhand State Govt only will be acceptable.
4. Documents should be uploaded by the firm under appropriate heads during the bid duration.
5. Contract can be cancelled with one month advance notice without assigning any reason.
6. For bonus and ESI component, monthly ceiling is of Rs. 21000/- (Basic wages). Bonus and ESI are not paid as monthly wages crosses Rs. 21000/-.
7. Contract may be extended with same terms and conditions for suitable period of 03/06 months with consent of both parties provided that (i) Satisfactory performance of services for the contract period. (ii) there is not downward trend in cost of services.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:
