However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Earnest Money Deposit (EMD) Submission Requirement: in reference to General Terms and Conditions on GeM 4.0 (Version 1.29) dt 25th March, 2026 as Buyer is State government autonomous body the submission of the Earnest Money Deposit (EMD) in hard copy before the due date of the bid is mandatory to the office of the Store Purchase Officer (SPO), DUVASU, Mathura. Keeping in view the importance of these goods and supplies, submission of the EMD in form of Fixed Deposit Receipt (FDR) from any scheduled bank in hard copy has been made compulsory, and no relaxation shall be provided to any category of bidder. In the event that the EMD is not submitted in hard copy before the due date, the bid of the concerned bidder shall be treated as technically disqualified, and no representation in this regard shall be entertained.
2. Scanned copy of the same shall be uploaded by Seller in the online bid and hard copy of the same will have to be submitted directly to the Buyer within 5 working days of bid opening, failing which the bid may be treated as incomplete & may lead to rejection of the bid by buyer without making any reference to the seller.
3. the bidder is advised to visit the site and submit site visit certificate in technical bid. failing which the technical bid of the concerned bidder will be rejected.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
