1. Vendor has to provide sufficient manpower for overhauling of 1 No ACE Hydra-12 T of NSPCL so that work can be completed in minimum time.

2. During visit, service engineer has to inspect the machine thoroughly and carry out the necessary replacement of materials.

3. After checking and servicing overhauling report to be prepared and signed jointly by vendor's service Engineer and EIC.

**Terms & Conditions:-**

6. Safety PPEs for service engineer (eg helmet etc) shall be brought by the visiting service person.
7. Any special service tool required for the hydra repair/ maintenance shall have to be brought by the agency.
