4. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated

23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the contractor is not able to provide vehicle of 2025 model or latest model, immediately on placement of order, he may be allowed to provide vehicle of model not below 2024 in place of ordered vehicle for a period of one month and for such lower model contractor shall be paid 90% of his quoted rates.

2.5. Contractor has to quote their rates considering acceptance of contract in total

ity and / no deviation is acceptable.

2.6. The Company also reserves the right to reduce or increase the number of vehicles to be supplied by giving 15 (Fifteen) days' notice and no claim whatsoever due to such reduction or increase in number of vehicles shall be entertained by the Company. The contractor shall supply the additional vehicle on same rates and terms & conditions.

2.7. The Company may at its own discretion decide to discontinue any vehicle(s) before expiry of the contract by giving 15 (Fifteen) days notice. No extra claim on this account shall be accepted. EIL reserves the right to amend the terms & conditions of contract after Mutual discussions and shall only be in writing.
