Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

(viii) PRE-QUALIFICATION CRITERIA :

Vendor will be eligible for participating against the requirement of PCBs on the basis of following conditions:-

1) For through hole PCBs (having through hole components):

■ Only manufacturer of electronic PCBs having assembly line for through Hole Components are eligible to participate. The firm should have the following machines in his assembly line- Automatic Temperature Controlled Soldering station/wave soldering machine, Component Performing Machines, Ultrasonic Cleaning machine, Conformal Coating Machine and Optical inspection system.

■ Vendor must have maintained ESD safe clean room area of class 100000 for assembly.

■ Vendor must have calibrated (from accredited labs) measuring/testing equipments used for testing of the PCBs.

■ Vendor should have qualified manpower capable of identification and handling of ESD safe electronics components.

■ Vendor must have at least three years of experience of supplying the similar type of MIL grade or other high end PCBs to Indian Army/Government departments or to reputed private firms.

■ All assembled PCBs submitted by the vendor will be tested for functional tests at Normal climatic conditions at OLF. After acceptance of the PCBs at NCC, firm will do the MIL grade conformal coating on the PCBs. After conformal Coating, the PCBs will be tested at HOT +50°/COLD -30° after integration in higher assembly.

■ Documentary proof for the above mentioned points is to be submitted by the firms along with the bid.

2) For SMD PCBs (having SMD components):

■ Only manufacturer of electronic assemblies, having automatic assembly line for SMD components {like ESD safe Temp. Controlled Soldering Stations, screen printer, pick and place machine, reflow oven, Optical inspection system and X-Ray (optional)} etc. Will be eligible. In case if the firm is not having the automatic assembly line, then the firm must have MoU with the other firm (having required infrastructure and expertise) from where they will get the PCBs assembled.

■ Vendor must have maintained ESD safe clean room area of class 100000 for assembly.

■ Vendor must have calibrated (from accredited labs) measuring/testing equipments used for testing of the PCBs.

■ Vendor should have qualified manpower capable of identification and handling of ESD safe electronics components.

■ Vendor must have at least three years of experience of supplying the similar type of MIL grade or other high end PCBs to Indian Army/Government departments or to reputed private firms.

■ All assembled PCBs submitted by the vendor will be tested for functional tests at Normal climatic conditions at OLF. After acceptance of the PCBs at NCC, firm will do the MIL grade conformal coating on the PCBs. After conformal Coating, the PCBs will be tested at HOT +50°/COLD -30° after integration in higher assembly.

■ Documentary proof for the above mentioned points is to be submitted by the firms along with the bid.
