4. Bidder must be from Uttar Pradesh State itself only. Copy must be attached for the same.

5. Every document are signed and stamped in given bid copy from the Gem portal.

6. Site Visit should be done by bidder from the publish of the bid and report to the concern office and physical demonstration of buyer office. Without Site visit or report to concern office bidder will not eligible for technical qualify for this bid. Copy must be attached.

7. The bidder must have the turnover as mentioned in the bid. A copy of the CA-certified turnover or Income Tax Return of the last 3 years must be uploaded with the bid

If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
