The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. 4. Past Performance of the Bidder/Tenderer: buyer reserves the right to reject the tender on receipt and/or on evaluation, if the past performance of the Bidder/tenderer has not been found satisfactory.

5. Discount: If any, to be indicated in the price format only

6. Certificate from the supplier that the material supplied under the contract should be provided then payment is due in accordance with the terms of contract at the time of presentation.

7. Buyer shall not be bound to accept the lowest bid/tender and reserves right to accept any or more bid/tenders in part. Decision of buyer in this connection shall be final.

8. THE BIDDER/TENDERER IS EXPECTED TO EXAMINE ALL INSTRUCTIONS, forms, terms, and specifications in the bidding documents. Failure to furnish all information required in the bidding documents or submitting a Bid not substantially responsive to the bidding documents in any respect may result in the rejection of the Bid.

9. PROFESSIONAL EXCELLENCE AND ETHICS. Bidding/Tendering Authority requires that all bidder/Tenderers participating in this Bid adhere to the highest ethical standards, both during the selection process and throughout the execution of the contract.

10. If the quality of the supplied material is found to be unsatisfactory fully or in part, the material will be rejected and the successful Bidder/tenderer will be held responsible to replace the material in full and without final replacement no payment shall be made.
