Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are

excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. As per policy, all government ministries, PSUs, and statutory bodies must procure steel that meets the “Melt & Pour” condition—i.e., melted and solidified in India

The tendered Item(s) are covered in Appendix- A of Notification No. 298 dt. 26th May 2025 i.e. List of iron and steel products which can only be procured from domestic sources with Melt & Pour Condition.

Melt & Pour is defined as the steel that has been produced in a steel-making furnace and poured into its first solid shape. The location where this process takes place is called the country of melt and pour (COM). The COM is the original location where crude steel is first produced in a liquid state and poured into its first solid shape. The first solid shape can be a semi-finished product, like a slab, billet, ingot, or a finished steel mill product.

The iron and steel must be melted and poured in India—this ensures the core material is domestically produced.

The Bidders must submit a self-certification undertaking (attached as “DMI&SP POLICY Format1”) along with their bid to confirm compliance with the policy’s domestic sourcing requirements
