- The 1 MT packing Size has been provided for bulk procurement through bid only. Actual container size in MT may be mentioned by buyer in BID document.

The material produced only by synthesis of pure chlorine and hydrogen shall be suitable for food grade. By-product acid from other chlor-organic processes is allowed only if it meets the total organic carbon limit in Table 1 of IS 265.

The product may also carry an ISI Mark/Standard Mark as per the BIS standard governing this category. As such Buyers may also opt for ISI marked product while creating BID. In such cases buyer shall verify valid BIS License for the same at the time of evaluation of BID and check ISI marking at the time of receipt of material before issuing CRAC.
