8. Certificates ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

9. Certificates To be eligible for award of contract, Bidder / OEM must possess following Certificates / Test Reports on the date of bid opening (to be uploaded with bid): No black list self declaration, Local area service center,, Undertaking on Notarized Stamp for Non-Blacklisted and Bankrupt, Upload notarized affidavit statement that all the Documents and statements mentioned in a document is true and correct .

10. Past Project Experience Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria: a. 11.
