2. BIDDERS TO REFER ATTACHED SCOPE OF WORKS, SPECIAL CONDITIONS OF TENDER, GENERAL CONDITIONS OF CONTRACT, INSTRUCTIONS TO BIDDERS (ITB), POLICIES FOR LAND BORDER RESTRICTIONS AND SOCIAL MEDIA GUIDELINES, HSSE POLICY OF BPCL AND OTHER TENDER DOCUMENTS FOR BID SUBMISSION.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
