1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 2. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority: Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid Inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. 6. **Buyer Added Bid Specific Scope Of Work(SOW)**

Text Clause(s)

- (1) To maintain administrative convenience and proper service, the registered office/regional office of the service provider should be located in Mahisagar or nearby districts.
- (2) The service provider must have minimum One year of experience in providing servants to any government office in the state of Gujarat and must submit a certificate stating that the work has been done satisfactorily.
- (3) The average turnover of the service provider for the last three financial years should be approximately Rs. 20.00 lakhs. Audited balance sheet of CA certificate need to upload for the same.
- (4) The agency must submit an affidavit on stamp paper that the agency has no outstanding dues to the government and has not been blacklisted by any office.
- (5) The L-1 firm should deposit 5% security deposit after placing the order, which should be returned after the completion of the contract period, taking into account satisfactory performance.
- (6) The L-1 agency should get service charge of 3.85%.
- (7) The L-1 firm should implement the minimum wage of the Government of Gujarat as per the rules of the Labour Commissioner's Office, Gandhinagar, as amended from time to time, during the contract period.
- (8) All the above documents should be uploaded at the time of submitting the bid
- (9) The agency should implement the rules of labour contract and PF.
- (10) The agency should submit the bill to the agency by the 5th of the month. The payment of which will b

e made after the grant is available. If there is a delay in paying the money to the agency due to lack of gra

nt, the agency will be responsible for paying the remuneration to the servant (pattawala) at its own expen
se from the 1st to the 5th of every month.

(12) The agency shall be liable for any loss or damage caused directly or indirectly to the office, any equip
ment or service, any property or property of the office, any government records or the property of the offic
ers/employees or any other loss or damage suffered by the government due to their incompetence, neglig
ence or intentional or any other reason.

(13) If the agency fails to provide this service satisfactorily and the office is dissatisfied with its services, th
e agency's security deposit will be forfeited and its services will be terminated, for which it will be given o
ne month's written notice. The office will not be liable for any costs, losses or any other inconvenience cau
sed thereby.

(14) Further, notwithstanding any provision contained in this agreement, the agreement may be terminat
ed by giving one month's notice to the competent authority/office agency without assigning an y reason. N
o compensation will be given for the remaining period of the agreement so terminated.

(15) If any dispute arises regarding the interpretation of any of the
terms of the agreement, the ARTO office Mahisagar decision will be final and binding on
all.
