- THE BIDDER MUST BE A REGISTERED FIRM/AGENCY/COMPANY UNDER THE COMPANIES ACT/ SOCIETIES REGISTRATION ACT FOR AT LEAST FIVE YEARS PRIOR TO THE BID PUBLICATION DATE.
- THE BIDDER MUST POSSESS VALID REGISTRATIONS UNDER GST, PAN, EPF & ESI ACTS, AND LABOUR DEPARTMENT.
- THE BIDDER MUST SUBMIT AN AFFIDAVIT ON A NON-JUDICIAL STAMP PAPER OF ₹100/-, DULY NOTARIZED, DECLARING THAT:

6. CONFIDENTIALITY
- THE AGENCY AND ITS PERSONNEL MUST MAINTAIN STRICT CONFIDENTIALITY OF ALL OFFICIAL DATA, DOCUMENTS, AND RECORDS HANDLED DURING DUTY.
7. ARBITRATION IN CASE OF A DISPUTE, THE MATTER SHALL BE REFERRED TO THE VC OF UOU HALDWANI, WHOSE DECISION SHALL BE FINAL TO THE EXTENT PERMITTED BY LAW.
- THE JURISDICTION FOR LEGAL PROCEEDINGS SHALL BE UTTARAKHAND.
8. DEPARTMENT'S RIGHTS
- THE DEPARTMENT RESERVES THE RIGHT TO ACCEPT OR REJECT ANY BID, IN WHOLE OR IN PART, WITHOUT ASSIGNING ANY REASON.
 - THE DEPARTMENT'S DECISION SHALL BE FINAL AND BINDING ON ALL BIDDERS.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
