1. indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

##### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 7.0 ELIGIBILITY CRITERIA-

#### 7.1 DETAILS OF SUPPLIES MADE TO GOVT. DEPARTMENT / GOVT. UNDERTAKING

The bidder shall submit statement containing details of manufactured, supplied minimum 01 No. HSC Centrifugal Pump having discharge capacity 50 Cusec or more to Government Departments/ Undertakings/PSUs directly or through their Authorized Representatives/Dealer up-to 31.03.2022 to Government Departments/Undertakings/ PSUs. To meet this requirement, the bidders shall submit copies of supply orders/invoices as a proof of supplies actually made. However, this condition shall not be applicable to those bidders who have already supplied same or higher capacity to Irrigation Department U.P., but they are required to furnish the details as required under this clause. If firm has supplied lesser number of pumps to Irrigation Department U.P. firm would have to submit the supply order/invoices for rest quantity.

#### 7.2 PERFORMANCE CERTIFICATES IN RESPECT OF SUPPLIES REFERRED ABOVE

The bidder shall submit performance certificates corresponding to the same supplies mentioned in "Supply Order Statement Annexure-A1" of satisfactory performance for a minimum period of 36 months related to the supplies executed. Performance Certificate must be issued in the name of Original Equipment Manufacturer (OEM) even though supply is made through their Authorized Representatives/Dealer. The bidders shall submit details of Performance Certificates in the format annexed as "Performance Certificate Statement Annexure-A2" herewith.

NOTE:-

(i) The above conditions 7.2 shall not be applicable to the bidders, who have supplied the HSC Centrifugal Pump of required discharge capacity as mentioned in 7.1 to Irrigation Department, U.P. but they are required to submit invariably the details of supplies made to Irrigation Department, U.P. in Supply Order Statement, Annexure A1. The performance in such case shall be evaluated on the basis of their past supplies at the departmental level, in case performance of their past supplies is found unsatisfactory or unwanted, their Technical Part shall primarily be rejected on this ground alone and no further evaluation of Technical Part shall be done. Such bidder may also please note that their consideration in earlier tender shall not be a basis of their claim for consideration in the ensuing tender. If firm has supplied lesser number of pumps, as required, to the Irrigation Department U.P., firm would have to submit the performance certificates of rest quantities of orders as mentioned in Annexure-A1.

#### 7.3 DETAILS REGARDING INFRASTRUCTURE FACILITIES

- (i) The Bidder has to provide The detail tested design of HSC Centrifugal Pump of required capacity 50 Cusec or more being/to be adopted by them. Bidders shall also submit Family Curve/ Characteristics curve.
- (ii) Plants, machineries and other facilities at their works for manufacture of HSC Centrifugal Pump of required capacity or more.
- (iii) Facilities available at their works for conducting full load tests on HSC Centrifugal Pump Centrifugal Pump of required capacity as required in relevant IS.

Bidders who had manufactured and supplied HSC Centrifugal Pump of required capacity as mentioned in 7.1 to irrigation department Uttar Pradesh need not to submit above information. If the bidder fails to meet eligibility criteria such offer shall be non-responsive and rejected outrightly.

#### 7.4 OEM PARTICIPATION:

Only OEM of the Horizontal Split Casing Centrifugal Pump/V.T. Pump can participate in bid.

Copy of Firm's industry registration and necessary information, as per clause 6.00 industry registration of ATC (additional terms and conditions) part-'D' technical conditions and technical specifications technical conditions, must be uploaded.

##### 7.4.1 OEM TURNOVER CRITERIA:-

The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March 2025 of previous financial year, should be as indicated in the bid document must be Rs. 6.00 Crore. Documentary evidence in the form of certified Audited balance sheet of relevant period and a certificate for the chartered account/cost accountant indicating the turnover details for the relevant period should be uploaded with the bid otherwise their offer shall be rejected.

In case of date of certification incorporation of the OEM is less than three years old, earn the average turnover in respect of the completed financial years, after the date of constitution shall be taken into account for this criteria.

7.4.2 The Bidder should not be under liquidation court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.

7.4.3 Bidder's offer is liable to be rejected if they don't upload any of the certificates/documents sought in the bid document, ATC and corrigendum if any."

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**

**For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.**

**The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
