Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2. Inspection

Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER): Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the Buyer. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. 7. **Certificates**

8. **Warranty**

Warranty period of the supplied products shall be 2 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. 1. Scope of supply (Bid price to include all cost components): Pre-Despatch Inspection, Supply, Installation, Commissioning, on-site training and warranty of Wireless Portable Under Vehicle Surveillance System (UVSS) as technical specification annexure attached.

2. Suppliers should upload document duly filled, signed and stamped regarding Self declaration with regards to Local content and also ensure that Local content percentage and location of value addition are clearly mentioned, strictly as per the format of **Annexure XI** attached in ATC document, otherwise offer will be

rejected.

3. Suppliers should also upload document duly filled, signed and stamped regarding land border sharing strictly as per Rule 144 (xi) of GFR, as per the format of **Annexure XII** attached in ATC document.

4. **Qualification of the Bidder:** The manufacturer shall have a proven technology for the manufacture of the UVSS and its accessories and provide service and supply of spares support for a minimum period of 5 years. The bidder shall have sufficient experience in the design, supply, installation, commissioning and maintenance of UVSS during the past three years from the date of floating of this tender. The bidder shall produce a proof of supply, installation, commissioning and maintenance of UVSS working elsewhere, along with the quotation.

5. Delivery:

The entire system shall be safely delivered to IGCAR stores, Kalpakkam by road, direct from supplier's works, without transshipment to avoid transit damages. The entire system designed, manufactured, tested, inspected and approved by the Purchaser shall be delivered, erected and commissioned at the site within 120 days from the date of placement of Purchase Order. The bidder's attention is drawn to the fact that no tender will be considered unless the bidder can satisfy the Purchaser that he can meet the delivery schedule specified as well as that he is prepared to carry out the work in the time slots made available.

6. Information to be included with the offer:

The bidder shall submit all the supporting information and technical data strictly in accordance with Section-B "Technical specifications and Quantity" of the technical specification annexure document attached to permit the Purchaser to make a detailed comparison and evaluation of Tenders without the need of calling for further information from the Bidder.

7. Packaging and Transport:

7.1 Bidders shall note that packaging for shipment shall be in accordance with the following instructions.

7.2 Equipments shall be packed and protected so as not to suffer deterioration, damage or breakage during shipment, trans-shipment and storage in a tropical climate

7.3 All lifting points shall be clearly marked.

7.4 Each package shall be properly labeled to indicate the type and quantity of material it contains, the Purchase Order number, dimensions, weights and any other necessary data to identify the equipment and relate it to the purchase order.

7.5 The supplier shall not ship the equipment without the prior approval of the Purchaser's Inspector and subsequent written instructions to do so.

8. The offer shall be kept valid for a period of 120 days from the date fixed for submission of tenders.

9. The following details shall be submitted along with the quotation:

9.1 Manufacturer's name and make, model number of individual items and their specifications.

9.2 Applicable standards for all items shall be submitted.

9.3 Details of experience in the supply, installation, and commissioning of systems similar in Nature both in magnitude and specifications.

9.4 List of approval agencies along with certificates.

9.5 Specifications and datasheets of all the constituent units of the system.

10. Functional Test:

All functional tests shall be conducted in the presence of the purchaser or their authorized representative at the supplier's premises during Pre Dispatch Inspection (PDI). The supplier shall prepare a comprehensive test procedure covering all components of the system. This document must be submitted for purchaser's approval prior to the commencement of testing.

11. **Continuous Run Test:** A continuous run test of the complete system shall be carried out for duration of 48 hours to verify both physical and functional integrity. The test shall include execution of self-diagnostic checks, alarm/trouble scenarios, and other relevant tests. No failures shall be permitted. Upon completi

on, detailed test reports shall be submitted to the purchaser before moving the system to the site.

12. **Site Testing:** Following factory acceptance, all equipment shall be properly packed and transported to the installation site. As transit may have a chance to cause damage, all factory-conducted hardware and software tests shall be repeated at the site. The equipment shall be accepted for the next phase (i.e., semi-industrial run) only upon satisfactory completion of site tests and approval by the purchaser.

13. **Real Plant Test / Semi-Industrial Run:** An extensive test run of the complete system shall be conducted under real plant conditions for a minimum duration of one month. The objective is to identify and eliminate any remaining hardware or software issues.

14. **Commissioning:** Upon successful completion of the semi-industrial run, the system shall be deemed commissioned. Following commissioning, the entire system shall be formally handed over to the purchaser. The supplier shall prepare and submit a detailed commissioning document, including all test results and relevant records.

15. **Warranty:** The equipment supplied shall carry a comprehensive on-site warranty (including parts and skilled manpower) for a period of 24 months from the date of commissioning.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
