Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

2. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1] Bidder must upload all the documents (**except price bid**) with **compliance status** mentioned in the technical bid (**with stamp and sign**) with supporting documents. Incomplete documents or without compliance of technical bid documents may liable for bid rejection. **Plz do not mention prices in technical bid, else bid will be rejected.**

2] Bidder has to quote total value as a package basis. After opening commercial bid, line-wise breakup of prices will be taken from L1 supplier as finalised by GEM, through email.

3] Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actual or as per applicable rates (whichever is lower) subject to maximum of quoted GST percentage.

4] EMD /SD amount **where applicable** shall be paid only through SBI Collect portal in online mode to Hindustan Aeronautics Ltd, Nasik Division. Further, **online deposit of the amount in any other form will not be accepted and may be invalid. The scanned image of deposit copy of earnest money deposit / SD , through SBI Collect , to be uploaded along with the Technical bid.**

STEP-1 Login to <https://www.onlinesbi.sbi/sbicollect>

STEP-2 Click on select category as “PSU-Public Sector Undertaking”

STEP-3 Filter by State as “Maharashtra “in the drop down menu. Thereafter select “PSU-Public Sector Undertaking” name as Hindustan Aeronautics Limited and Click.

STEP-4 Select Payment Category as “RECEIPT FROM SUPPLIER / VENDORS/ CONTRACTORS / OTHERS” and Fill-up the respective information correctly and Select purpose of Transfer as “EMD / Security Deposit / Tender fee (As applicable) , Select “ Nature of Supplier” as applicable . Fill details correctly and Click “Submit ”

STEP-5 If all details entered are correctly populated, click “NEXT” to proceed. Verify the payment Details, Click “Next” to proceed.

STEP-6 Make payment as per your convenience. (Options available are payment of

fees through Net Banking / Card Payments/ Other Payment Modes)

STEP-7 Print Receipt and upload in the technical bid of portal.

5. Security Deposit (SD): 5% of total order value (Excluding GST) to be submitted within 15 days of issuance of Purchase/ Contract Order till the completion of Supply item.

6. For MSMEs & Start-ups, 15% (of the basic price) interest free Advance shall be payable against BG of equivalent amount, balance 85% shall be paid within 30 days of receipt and acceptance at our stores. In case 15% Advance is not sought by the vendor, 100% payment shall be made within 30 days of receipt and acceptance at our stores.

7. If bidder is MSME, then bidder must confirm following category: (a) Women (Yes / No), and (b) SC / ST (Yes / No).

8. Vendor should visit the HAL site before submitting the bid for better understanding of scope of work. Also submit the pre-bid meeting MOM at the time of tendering.

9. Though the Pre-bid date and time is proposed on 24.03.26 @ 15:00 as required by GeM portal, in practical the service provider's representative can visit any day between tender date and 24.03.26 @ 15:00 to HAL site for Pre-bid.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
