3. Terms and Conditions stipulated in ATC will supersede those in GeM GTC and STC in case of any conflicting provisions. **Further, GeM Service Level Agreement (SLA) of the category is also not applicable for this tender.**
4. Bidders are required to submit the documents mentioned in the check list appended below while submitting their bid and submit the duly filled check list online on GeM portal. 5. Instructions for filling the Price Bid:

6. MSE Benefits are Applicable for this work. 8. **All the bidders are required to furnish PAN & GSTIN of their firm and NTPC Enlistment Circular copy issued to them along with their bid.**
9. **Bidders may please note that GeM is capturing and showing the IP addresses used by the Buyer and the Bidder(s) /Seller(s). The received bids having matching/common IP address with either Bidder(s)/Seller(s) or Buyer, shall be outrightly rejected & shall not be considered for further evaluation.**
10. **This tender is only for NTPC Enlisted Vendors for the designated Enlistment Group/Category who meets the Average Annual Turnover (AATO) and Execution Capability (EC) criteria as indicated under Clause 5.0 of Section-I NIT. Bids received by any other bidder not meeting the referred criteria shall be outrightly rejected during technical evaluation.**
11. Bidders are advised to mention their prices at the designated place on the GeM portal only as the same shall only be considered for evaluation and price content mentioned / uploaded along with any other documents in their bid shall not be considered in any case.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and

conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
