1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

SCOPE OF WORK AND T&C

-

SCOPE:

1. The work shall be executed under the BOP Scope of work at 3 X 660 MW, NUPPL, Ghatampur (UP). For this package payment shall be directly released by NUPPL.
-
2. Deployment of expert engineer/technician by M/s HYOSUNG T&D INDIA PRIVATE LIMITED for inspection of 400kV GIS materials supplied by Hyosung at NUPPL site, including the rough internal and external inspection of each material, witnessing testing and verification of equipments for erection and consolidation of material list to be repaired/procured. Repairing and servicing of the materials at site (wherever possible) shall also be carried out under this work order. For material which is not repairable at site, the same shall be sent to vendor location for repair/ service at extra cost which shall be mutually discussed & finalized. Separate PO/SO shall be placed for such materials.
3. All material verification and rectification works shall be done under the direct supervision and responsibility of M/s HYOSUNG T&D INDIA PRIVATE LIMITED - Engineer/Technician.
4. The Engineer/Technician deputed for the job should have sufficient job experience in 400kV GIS in the specific field of erection, commissioning, testing and troubleshooting of GIS equipments/material.
5. M/s Hyosung engineer will oversee and witness all pre-erection equipment/material healthiness. Additionally, they will be responsible for providing all necessary erection clearances.
6. M/s Hyosung is required to depute Engineer and Technician for a total of **68 man-days each**, which may be split into multiple visits over **3 months period** from the date of issue of Service Order (SO) from NUPPL. M/s HYOSUNG shall depute manpower to the site within maximum 2 weeks of receiving intimation from NUPPL. However, M/s Hyosung shall ensure deputation of manpower at site as early as possible after intimation from NUPPL.
7. Man days (visit duration) will be reckoned from the day Engineer reaches the site till he leaves the site during a visit. For each visit additional two (2) man-days will be considered as travel day cost per person. No extra charges shall be paid for travelling. In a single visit the Engineer may work as per the available front. For any idle days at site, due to reasons not attributable to M/s Hyosung, then the idle days will be considered as working days.
8. If work cannot proceed at the site due to weather conditions or the unavailability of the work front, NUPPL will provide prior intimation to release Hyosung manpower.
9. Mobilization of Manpower to site shall be in scope of M/s HYOSUNG T&D INDIA PRIVATE LIMITED. Additional 2 man-days shall be considered for each visit per person for travelling.
10. Accommodation and local conveyance at GTPP site will be provided by NUPPL free of cost. However, if NUPPL is not able to provide accommodation and local conveyance then M/s Hyosung may arrange the same by themselves. The amount incurred shall be reimbursed by NUPPL as per actuals.

- 11.** The normal working hours per day will be 08 (eight) hours between 09:00 HRS and 18:00 HRS with a lunch break of 01 (one) hour. No additional working hours will be envisaged beyond the normal working hours in a day.
- 12.** Skilled/Unskilled manpower/assistance with material shall be provided by NUPPL. All types of Cranes/Hydra/Lifter/Dryer for executing the work shall be provided by NUPPL. However, any specialized tool categorically required to execute the job shall be arranged by M/s Hyosung.
- 13.** M/s Hyosung's manpower shall ensure strict adherence to work safety protocols and comply with all NUPPL safety regulations. Should any accident, fatal or otherwise, occur during the execution of works, M/s HYOSUNG T&D INDIA PRIVATE LIMITED shall keep NUPPL fully indemnified against all risks, claims, litigations, and financial burdens arising out of the same.

DOCUMENTATION:

- 1.** The engineer shall prepare the report of the works carried out; equipments/materials inspected under his supervision and submit the same on weekly basis.
- 2.** A Minutes of Meeting (MOM) will be prepared and signed after every visit to certify completion of work during that visit. In case work cannot be completed in the visit, still a MOM shall be prepared for record of work.
- 3.** Attendance sheet to be maintained duly signed by NUPPL. HR compliance is not applicable.

TERMS OF PAYMENT:

- 1.** 100% Payment shall be released against submission of certified bill within 30 days from completion of work. Payment shall be released on prorated basis (i.e after each visit) after submission of Visit work report and duly signed attendance sheet.
 - No Advance Payment shall be made.
- 2.** The following documents shall be submitted along with RA bill:
 - RA Bill & Invoice, in Original, duly signed by M/s Hyosung authorized representative.
 - Attendance sheet
 - Work executed Report for each visit – for processing of Bill
 - All applicable statutory compliances

Mode of Payment:

- For this package payment shall be directly released by NUPPL upon the completion of work. Any interest on overdue payments is not acceptable, under any circumstances. Any interest claims by supplier in their invoices will not be entertained.

Duration of Contract

- 3 Months (90 days) from the date of issue of Service Order (SO) from NUPPL.

Other Conditions:

-

1. The Bidder shall declare that their company is not banned/debarred/blacklisted by other Central Public Sector Enterprises (CPSEs)/Government Entities as on the original scheduled date of Bid opening. In case while processing the Bid or during post award of Bid, any such banned/Debarred/Blacklisted instances by other Central Public Sector Enterprises (CPSEs)/Government Entities, is known to NLCIL/NUPPL then the bidder will be disqualified for that particular Bid, if the Bid is under process. If already awarded, then the Purchase Order/Contract will be terminated. In the above circumstances, Bidder shall not have any claim on NLCIL/NUPPL towards such disqualification or termination of Contract/Purchase Order. The Bidders shall submit the declaration as per the format attached.

2. **Bidders must upload a certificate as per format attached in Buyer Added Bid Specific ATC from the bidder regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected.**
3. **Preference to Make in India:** MII Purchase Preference is applicable as per O/o No. P-45021/2/2017-PP (BE-II) – Part (4) Vol. II Dated: 19th July, 2024 issued by Ministry of Commerce and Industry, DPIIT, Government of India.

Verification of Local Content: The bidder shall give self-certification for local content in the quoted item (goods/works/services) at the time of tendering. However, at the time of execution of the project, for all Contracts above INR 10 Crore, the contractor/supplier shall be required to give local content certification duly certified by cost/chartered accountant in practice. For cases where it is not possible to provide certification by Cost/Chartered Accountant at the time of execution of project, the supplier shall be permitted to provide the certificate for local content from Cost/Chartered Accountant after completion of the contract, within time limit acceptable to the procuring entity. In case the Contractor/supplier does not meet the stipulated local content requirement and the category of the supplier changes from Class-I to Class-II/ Non-local or from Class-II to Non-local, a penalty up to 10% of the contract value may be imposed. The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
