Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. 4. All driver/concerned staff should be well aware about material safety data sheet (MSDS) of the hazardous chemical they are carrying and it must be implemented whenever applicable as the case may be.

B) The material shall be supplied in road tanker preferably with compressed air unloading system. Suitable and safe unloading hose pipe, flange, clamps & other fittings up to unloading pump inlet pipe shall be provided (on returnable basis) by the supplier with the tanker at the time of each supply.

C) All necessary safety PPE's (face shield, full apron, hand gloves, gum boots, safety harness (for work at height) should be available with tanker during unloading. NSPCL will assist in unloading of material at site into the storage tanks.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-

compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
