NTPC enlisted vendors for the Contractor Enlistment group MP-02 - "Packages having scope of works of deployment of manpower (which also includes deployment of 'Specialized/ expert manpower' as defined at '1A' and '1B' of QR-SOW available on vdc web portal <https://vdc.ntpc.co.in>) for assistance in NTPC Stations/Projects/Sites/ Offices (MP-02)" with Average Annual Turn Over (AATO) & EC (Execution Capability) equal to or more than Rs. 65,60,056.00 can only participate in this tender. Bids received from other than enlisted bidders shall not be considered and the same shall be rejected. Bids received from enlisted bidders not meeting the above mentioned AATO and EC criterias shall be rejected during technical evaluation.

(ii). If non enlisted/rejected vendors are interested to participate, can do so in future tenders first by enlisting themselves for the respective Contract Enlistment category (CEG). They shall have to visit NTPC CPC website <https://vdc.ntpc.co.in> and submit online application against items/services (Material /Contract Enlistment Groups) of their choice. If they meet the criteria stipulated in the Qualifying Requirement, they shall be enlisted in line with the Terms and Conditions of enlistment.

(iii). All participating vendors in this tender shall submit their latest enlistment certificate issued to them with mention of AATO & EC values for the item category (CEG) or submit any other proof of their enlistment in which AATO & EC along with CEG is mentioned. Else vendors may also attach the mail sent to them by the C&M /buyer department for participation in this specific tender.

2) Instructions for filling the Price Bid: The bidder has to quote the service charge (in percentage) inclusive of GST. Complete bid document is uploaded in ATC, refer BOQ and Scope of work on page 09-15.

3) EMD exemption shall be applicable as per GEM GTC. For EMD exemption as per GEM GTC, bidder has to only upload the scanned copy of relevant document on GEM for the same.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
