Documentary evidence in the form of certified Audited Balance sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turn over in respect of the completed financial years after the date of constitution shall be taken into account for this criteria ". **This may be ignored.**

**The following annual turnover will only be considered for a evaluation:**

**T1- Annual Turnover.**

The bidder should have an annual financial turnover not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year up to the date of opening of the tender.

The audited balance sheet reflecting financial turnover certified by chartered accountant with her/his stamp, signature and membership number shall be considered.

**T2-Liquidity:**

**The bidder should have access to or has available liquid assets, lines of credit and other financial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's commitments for other contracts. The audited balance sheet and/or banking reference certified by chartered accountant with her/his stamp, signature and membership number shall be submitted by the bidder along with bid.**

Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the Joint Venture/Consortium. In case the Net Current Assets (as seen from the Balance Sheets) are negative, only the Banking references will be considered. Work experience certificate from private individual shall not be accepted. Certificate from public listed company/private company/Trusts having annual turnover of Rs.500 crore and above subject to the same being issued from their Head office by a person of the company duly enclosing his authorization by the Management for issuing such credentials.

**Notes:**

The bidder shall submit details of work executed by them in the prescribed format along with bid for the service contracts to be considered for qualification of work experience criteria clearly indicating the nature/scope of contract, actual completion cost and actual date of completion for such contract.

- (3) Due to GeM portal technical limitations, the past experience of similar service requirement was mentioned as: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty per cent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty per cent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty per cent) of the estimated cost.

**This may be ignored.**

**The following work experience will only be considered for a evaluation:**

Work experience certificate from private individual shall not be accepted. (4) **Earnest Money Deposit:**

Bidders shall upload EMD paid particulars document or exemption documents in the relevant section of GeM while quoting the bid.

(7) Copy of an undertaking that the tenderer is not blacklisted or debarred by Railways or any other Ministry/Department of Govt. of India from participation in tender on the date of opening of bids.

(8) The successful bidder is required to submit the performance guarantee as per para no. 4.11 of PART-I OF **GENERAL CONDITIONS OF CONTRACT** enclosed herewith.

(9) Since, the subject service is being called through GeM portal, due to technical limitations in the portal GeM contract order being generated initially needs to be treated as Letter of Acceptance.

(10) The contract agreement will be executed only after the submission of the PG to the requisite value as per the tender condition and this signed contract conditions will only being treated as original contract order. Hence, Bidders are advised to make note of it and follow the same accordingly.

(11) Contract will be executed based on the terms and conditions mentioned at SCOPE, SPECIAL CONDITIONS OF CONTRACT enclosed herewith.
