1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023. [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and

for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

Special terms and conditions-Version:1 effective from 14-10-2024 for category Ordinary Portland Cement (V3) Confirming to IS 269

1. Note to Buyers:

The Central Ministries/ Departments and other government buyers, as applicable, shall note that this category is covered under Scheme - I (ISI Mark Scheme) of BIS (Bureau of Indian Standards).

Compulsory use of Standard Mark - Goods or articles shall conform to the corresponding Indian Standard and shall bear the Standard Mark under a license from the Bureau as per Scheme-1 of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018:

Buyer shall verify and confirm compliance with the applicable BIS order during the procurement and fulfillment process.

Note to Sellers:

Sellers shall offer and supply products conforming to the corresponding Indian Standard and bear the Standard Mark under a license from the Bureau as per Scheme-1.

Non-compliance shall result in action as per GeM IM policy.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Only OEMs/OEM Authorised Dealers are allowed to participate in the bid. Bidders must upload OEM certificate.
2. Test certificate for compliance of the properties of the materials as per specified standard under relevant recognized codes as per IS: 269: 2015 and latest should be uploaded.
- 3) Past Performance :
 - a) The supplier must have a minimum GeM rating of 4.25 or above at the time of bid submission. No relaxation will be permitted.

b) Any record of short supply/requested for extension of DoD in past contracts regardless of justification shall all lead to outright technical disqualification. No appeal or clarification shall be entertained in this regard.

4. **Inspection of Stores** : The supplied stores to be checked by a Technical Board of Officer detailed by accepting officer.

5. **Rejected Stores** : All rejected stores are liable to be back loaded by seller within seven days from consignee location at own risk and cost in case of stores not accepted by TBOO.

6. **Cancellation of Bid** : Competent Authority will have the right to cancel the bid at any stage of procurement process including after opening of financial bid and Reverse Auction without assigning any reason to seller. No representation will be entertained in this regards.

7. **Payment terms & Condition**: Payment will be released after supply & as per GeM Terms & Conditions .

8. **Payment Authority**: PCDA (BR), New Delhi.

9. **Notes:-**

(a) Consignee shall ensure validity of approval of firm and brand at the time of execution of work. The Supplier shall furnish the particulars of the manufacturer of cement along with the date of manufacturing of cement to the Consignee for every lot of cement separately. For each lot of cement brought by the Supplier, before acceptance of the cement the following actions will be taken by the CONSIGNEE and Commander TF:-

(i) Inspect the lot and verify the general conditions of the cement.

(ii) Obtain the vouchers (IN ORIGINAL) of the manufacture of cement for each lot containing the date of manufacturing, from the Supplier.

(iii) Obtain from the Supplier for each lot of cement the manufacturer's Test Certificate (IN ORIGINAL) along with Test Sheets giving the result of each physical test and chemical composition of cement or authenticated copy thereof duly signed by manufacturer. The test report should also show the chemical properties of the cement as per relevant IS Codes.

The cement so brought shall be fresh and in no case older than 30 days from the date of manufacture. The CONSIGNEE accordingly in consultation with the Supplier will work out the Schedule of procurement and ensure that the same is adhered to. The document in support of the purchases of cement shall be verified by the Commander TF. Cement shall conform to the requirement of Indian Standard Specification and each bag of cement shall bear relevant ISI mark. The weight of each consignment shall be verified by the CONSIGNEE and recorded. The content of cement shall be checked at random to verify the actual weight of cement per bag. However, the content of cement per bag shall be 50 Kg only subject to tolerance given in relevant IS code.

b) TESTING OF CEMENT

The Supplier shall submit the manufacturer's test certificate in original or attested true copy along with test sheets giving the results of each physical test as applicable in accordance with relevant IS provision and the chemical composition of cement or authenticated copy thereof duly signed by the manufacturer with each consignment, as per the following IS provision :-

(i) Method of sampling hydraulic cement as per IS-3535.

(ii) Method of physical test for hydraulic cements as per IS 4031.

iii) Methods of chemical analysis of hydraulic cement as per IS-4032.

c) INDEPENDENT TESTING OF CEMENT BY CONSIGNEE

The decision as to where the testing of cement is to be done shall be taken by CONSIGNEE. In case the CONSIGNEE decides to carry out independent testing, the testing should be as per the tests mentioned in the 'CEMENT SUPPLY / ACCEPTANCE FORM' (Physical and Chemical requirement) of random samples of cement drawn from various lots. The testing shall be carried out through National test house, SEMT, CME, Regional Research Laboratories, Govt approved Laboratories, Zonal Laboratories, from any Govt Engg College, Govt aided College or NABL labs as per IS-3535 (method of sampling hydraulic cement), IS-4031 (method of physical test for hydraulic cement) and IS-4032 (Method of chemical analysis of hydraulic cement) referred to above. In case the cement is not of requisite standard despite manufacturer's test certificate, the Supplier shall remove the total consignment from the site within 24 hours at his own cost after written rejection order of the consignment by the CONSIGNEE. The cost of testing, transportation and of material used in testing etc. shall be borne by the Supplier irrespective of the results of testing and no extra claim whatsoever shall be admissible.

d) DOCUMENTATION

(i) The Supplier shall submit original purchase vouchers for the total quantity of cement supplied under each consignment to be incorporated in the work. All consignments received at the work site shall be inspected by the CONSIGNEE along with the relevant documents to ensure the requirements as mentioned hereinbefore, before acceptance. The original purchase vouchers and the test certificates shall be verified for subject contract and defaced by the Commander TF and kept on record in the office of the Consignee duly authenticated and with cross reference to the consignment/control number recorded in the Cement Acceptance Register. The cement acceptance register shall be signed by the Junior Engineer (Civil), OC RCC/BC C, CONSIGNEE and the Supplier. The Commander TF will personally check the documents concerned with cement periodically at least once in a month and record of these checks will be kept in the cement Acceptance Registers. The Supplier shall maintain schedule of supply of cement for each consignment.

e) **DELIVERY** : Delivery to be completed by successful Seller within **120 days** from the date of placing of GeM contract. Delivery Condition: The delivery location of above items are as under-

2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
