1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. 4. 5. 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

5. **Certificates**

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

Additional Terms & Conditions (ATC)

1. **OEM Authorization / Dealership Certificate:**

The bidder shall submit a valid Authorization Certificate / Dealership Certificate issued by the Original Equipment Manufacturer (OEM), clearly authorizing the bidder to supply the quoted items. In case the bidder is not the manufacturer of the goods to be supplied, submission of OEM authorization in favour of the bidder is mandatory. Failure to submit the same shall render the bid non-responsive.

2. **Product Catalogue Submission:**

The bidder shall submit product catalogues/brochures for all items proposed to be supplied. The catalogue must clearly mention the following details:

- Product photograph/image
- Model name / Product code
- Brand / OEM name
- Detailed technical specifications

Catalogues without the above details shall not be considered valid.

3. **Past Supply Experience:**

The bidder shall submit documentary proof of previous supply experience in sports equipment / weightlifting / archery equipment, such as copies of supply orders/work orders and/or completion certificates issued by Government / Semi-Government / PSUs / Autonomous Bodies / recognized institutio

- ns.
4. **After-Sales Service Support:**
The bidder shall submit a valid After-Sales Service Agreement/Undertaking confirming provision of maintenance, service support, and replacement/repair support during the warranty period.
 5. **Transit Insurance:**
Transit insurance for the entire consignment shall be arranged and borne by the supplier until safe delivery and acceptance of the items at the consignee location.
 6. **Warranty:**
All supplied items shall carry a minimum warranty of 01 (one) year from the date of successful delivery and acceptance.
Wherever higher warranty is prescribed in the technical specifications, the same shall prevail.
 7. **Declaration on Non-Blacklisting / Non-Debarment (Compulsory):**
The bidder shall submit an undertaking declaring that the firm has not been blacklisted or debarred by any Central Government / State Government / PSUs / Autonomous Bodies at any point of time.
 8. **Price Reasonability Certificate / Undertaking (Compulsory):**
The bidder shall submit a Price Reasonability Certificate/Undertaking (scanned copy) stating that the rates quoted are not higher than the rates at which the same items were supplied by the bidder to any Government Organization / Institution / PSU.
 9. **Country of Origin Restriction:**
Items of Chinese origin ("Made in China") shall not be accepted.
The bidder must clearly specify the brand and model number of each item being offered. Bids without brand and model details are liable to be rejected.
 10. **Year of Manufacture:**
The year of manufacture of the items offered shall not be more than one (01) year old from the date of supply.
 11. **Compliance with International Standards:**
The product offered shall conform to the requirements and standards prescribed by the International Weightlifting Federation (IWF).
 12. **Product Certification Requirement:**
The items offered shall be designed specifically for competitive Olympic weightlifting and certified/approved by the International Weightlifting Federation (IWF).
 13. **Mandatory Document Submission Clause:**
All documents, undertakings, and certificates mentioned above are compulsory.
Non-submission of any required document shall result in summary rejection of the bid, as the bid shall be treated as non-responsive.
 14. **Rejection of Non-Compliant Bids:**
The buyer reserves the right to reject any bid found incomplete, non-responsive, or not in conformity with the above Additional Terms & Conditions, without assigning any reason.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
