TERMS OF PAYMENT

1. 95% of the basic price and 100 % of taxes shall be released after the successful commissioning and completion of Installation of the equipment and on submission of the following documents. Separate GST "e" invoices for showing goods description, break up of taxes and total amount towards the payment mentioning KSEBL GST No.32A AECK2ZTTNBZI shall be drawn in triplicate in favour of Deputy Chief Engineer, System operation Circle Thiruvananthapuram.

2. Warranty Certificate in company letter head or as provided by the OEM

3. Site Acceptance document duly signed by Engineer at Site and Engineer deputed by the contractor.

4. Balance 5(Five) percent of the basic price will be paid after the satisfactory completion of the guarantee period. Alternatively, this 5% shall be paid on submission of the performance Bank Guarantee from a Nationalized/scheduled bank for an amount equivalent to 5 % of the total contract amount valid up to 2 months after the expiry of guarantee period.

Other Important ATC:

- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

6. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

7. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

8. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Performance Security of the successful bidder shall be forfeited if it fails to accept the AMC contract when called upon by the buyer. The original Performance Security of contract will be returned only after submission and verification of AMC Performance Security for 5% of total AMC value valid up to AMC period plus 2 months (if there is no other claim). 5. Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

6. Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 3 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to reimburse the cost of such service / rectification to the Buyer.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
