02) The Bidder must have upload ITR last three financial years.

05) It is mandatory for every bidder to Visit the Maintenance site and make a report of all scope of work with Maintenance Accessories and it submit to department before Bid end date and submit acknowledgment of the same with Tender documents .

06) The Bidder must have upload MII & local content Declaration; Bid security Declaration must be attached.

07) Emd submission is must. No Exemption allowed.

08) Bidder should attach minimum 5 GEM order of govt supply.

09) The bidder must have to submit a Declaration on INR 100 Judicial Stamp duly notarized for Not having been debarred/blacklisted either by the any Bid Inviting Authority or by any organization functional under Central/ State government/ Semi-government/ PSUs of central/ State governments. Participated in this bid only after receiving OEM authorization. I will have no objection to the technical committee decision I accept the decision

10) The bidder must submit copy of organization / firm PAN Number, GST certificate, MSME/Udhyam registration, MP PWD registered license and electrical contractor license issue by M.P. LICENSINGBOARD (ELECTRICAL) in Class "A"category .

11) All Mechanical work including labour and other cost will be borne by the seller while installing & fixing all Accessories/material.

12) Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
