1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. Generic

- (i) Subject bid has been floated for procurement of furniture required for **Audit Room of Finance Department** by taking due approval of competent authority for floating bid on PAC basis hence, offered / quoted items should be of **"GODREJ INTERIO"** make and hence unbranded or any other brand / make other than **"GODREJ INTERIO"** make is not acceptable.
- (ii) The bidder should be OEM (i.e. **M/s Godrej & Boyce Mfg. Co. Ltd.**) of the tendered item/s or their sole selling agent/authorized dealer/distributors (Whenever Manufacturer (OEM) is not quoting directly as a matter of their policy) are entitled to quote for the tendered item/s.
- (iii) In case bidder / seller is a sole selling agent / authorized dealer / distributor of OEM, then they must submit specific authorization letter from their principal (i.e. OEM of the tendered item/s) to quote against the Bid / tender (incorporating Bid Reference no. in authorization letter). The authorization letter duly notarized & self-attested for specific tender should be submitted along with their offer by the seller quoting on behalf their principal (i.e. OEM of the tendered item/s).
- (iv) In case after opening of Part-I Bid, it is found that the bidder has participated on behalf of their principal manufacturer (OEM of the tendered item/s) attaching the authorization letter, then authenticity of the same may be examined on getting confirmation from the Original Equipment Manufacturer, if necessary.
- (v) Failure to submit any of the above document(s) may render a tender unacceptable.

2. NOTE :

- Make and Model is mandatorily required to be submitted in Bid itself. The bid without make or model will not be considered technically acceptable. The Performance Security/Security Deposit equivalent to 5% of total landed value of contract (including all taxes, duties and other costs and charges, without considering Input Tax Credit) shall remain valid for at least 3 months after the completion of supply and material acceptance at consignee end.

Performance Security/Security Deposit will be released with the approval of AREA GENERAL MANAGER, KUSMUNDA AREA within 30 days after completion of supplies and acceptance of material by the consignee and submission of Performance Bank Guarantee(s) in case of supply contract or after successful commissioning and on receipt of confirmation of Performance Bank Guarantee(s) for all the equipment covered in the contract in case of contracts for equipment and all those items/goods involving installation and commissioning and PBG.

Security Deposit may be converted into Performance Bank Guarantee (PBG) wherever PBG is required at the option of the supplier. At the time of conversion of security money into PBG, it should be ensured that the amount of PBG should not be less than 10% of equipment landed value along with maximum annual landed value of spares & consumables/AMC/CMC. Wherever Security Deposit is converted into PBG, the operation of such SDBG/Performance BG shall be guided by Performance Bank Guarantee Clause.
