Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

**Special terms and conditions-Version:1 effective from 17-10-2025 for category Rotational Moulded Polyethylene Water Storage Tanks (V3) Conforming to IS 12701**

1. These tanks are not meant for underground applications. It does not cover mobile water tanks and horizontal cylindrical water tanks. Nominal service temperature from +1 degree Celsius to +50 degree Celsius.

The product may also carry an ISI Mark/Standard Mark as per the BIS standard governing this category. As such, Buyers may also opt for ISI marked products while creating BID by mentioning their requirement in Bid ATC. Availability of License to vendors in this category needs to be checked by Buyer at their end, in case they add any such conditions in Bid ATC. Further, in such cases, buyer shall verify a valid BIS License for the same at the time of evaluation of the BID and check the ISI marking at the time of receipt of the material before issuing CRAC.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
