Special terms and conditions-Version:2 effective from 10-11-2025 for category Hopper Tipper Dumper for Garbage**1. Special Terms and Conditions for Hopper Tipper Dumper for Garbage**

- This category is created to cater to the requirement of buyer for procurement of Hopper Tipper for garbage collection. This category is a **BID-ONLY Category**, and procurement will occur exclusively through the bidding process.
- The detailed specifications for the fabricated tipper container is to be defined by the buyer in the bid. These may include the following parameters :
 - Dimensions of garbage tipper container
 - Grade of material to be used for tipper construction
 - Payload Capacity defined in the category is the total of weight of container body and weight of material to be carried. Buyer may like to define minimum container weight required as per the selected tipper container capacity/volume (cubic meters). Additionally, Buyers may estimate the weight of the material based on the density of the waste intended to be collected. Based on these two inputs- container weight and weight of material to be carried, payload capacity may be selected while creating the bid.
 - Minimum gross vehicle weight of chassis to be allowed for the required tipper.
- Buyer may seek Chassis / Original Vehicle Manufacturer's authorization from Body Builders in the bid.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the

additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. ctional local service centre within the purchaser's jurisdiction. The centre must be adequately staffed and equipped to handle all warranty-related issues, repairs, and technical concerns promptly. Failure to meet this obligation will be considered a severe breach of contract. Bidders must submit a precise Bill of Materials (BOQ) demonstrating full compliance with all technical specifications. Any discrepancies, omissions, or unclear responses will result in immediate rejection of the bid, with no further discussions. Bidders must submit all necessary statutory and tender-related documents as per the tender requirements. Form T-6 duly filled and signed; An affidavit affirming the validity of the bid for a minimum of ninety (90) calendar days from the date of opening; and Any additional instruments or declarations demanded by the tendering authority. Non-submission of even a single prescribed document shall render the bid technically non-responsive.

Mandatory Statutory Registrations: The bidder must enclose certified copies of the following statutory instruments: Permanent Account Number (PAN) issued by the Income Tax Department; Firm Registration Certificate evidencing legal constitution; and Goods and Services Tax (GST) Registration Certificate. Failure to produce any of the above documents shall be viewed as non-fulfillment of eligibility criteria.

Financial Credentials and Tax Compliance: The bidder shall furnish audited financial statements (including balance sheets and profit-and-loss accounts) and income tax return copies for the preceding three (3) financial years, duly certified by a chartered accountant. The submission must also compulsorily include the Income Tax Return for the Financial Year 2024-2025. Absence of these documents shall be treated as evidence of inadequate financial standing.

Payment Terms and Verification Protocol: Under no circumstances shall advance payment be sanctioned or released to the contractor. The entirety of the contractual consideration shall become payable only upon satisfactory verification, inspection, and certification of the deliverables by the competent authority, whose decision shall be final and binding.

Departmental Discretion in Bid Acceptance or Rejection: The Department shall retain absolute, unfettered, and discretionary authority to accept or reject any bid, or to annul or terminate the tendering process in its entirety at any stage, without the necessity of assigning any justification or cause. The Department shall not be bound to accept the lowest bid. An affidavit acknowledging and accepting this condition must be submitted by the bidder.

Non-Blacklisting Affidavit: A Non-Blacklisting Certificate executed on a ₹100 (Rupees One Hundred) non-judicial stamp paper, duly notarized by a Notary Public, shall be mandatorily submitted. The affidavit shall explicitly state that neither the bidder nor its allied entities have been blacklisted or debarred by any government, semi-government, or public sector institution.

OEM Authorization Letter: An Authorization Letter issued on the official letterhead of the Original Equipment Manufacturer (OEM), bearing reference to the specific tender number and addressed directly to the Tender Inviting Authority, must be submitted. The absence of such authorization shall result in immediate disqualification of the bidder.

Non-Applicability of EMD Exemption: No exemption, relaxation, or waiver whatsoever shall be permissible concerning the Earnest Money Deposit (EMD) requirement. Every bidder shall deposit the prescribed amount without exception.

Termination on Account of Delayed Supply: solvency certificate issued by dm/Bank minimum 50 Lakh is mandatory to be uploaded along with bid documents. Gstr-9 of latest three years to be uploaded of bidder. Stamp papers shall be purchased between bid start and end date, otherwise the affidavit shall not be considered valid. All the affidavits and tender documents shall be self attested by signing person/authorized signatory/proprietor with stamp. Should the supplier fail to deliver the contracted materials within the stipulated delivery schedule, the work order shall stand terminated forthwith, without any consideration or liability accruing to the purchaser. No extension of time shall be entertained except under exceptional circumstances duly justified in writing.

Compulsory Submission of Authorization Certificates: Any bid submitted without the mandatory OEM authorization certificate shall be deemed non-complaint abilities and shall not be considered for technical or financial evaluation.

If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
