If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

6. **Certificates**

7. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

8. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

9. **Buyer Added Bid Specific ATC**

1. The hired vehicle shall be parked at location as directed by the consignee officer.

	1	The vehicle shall either be owned by the tenderer or the tenderer should have the partnership deed with the party whose vehicle the tenderer intends to offer. The tenderer should submit the authorization certificate from the owner for the use of vehicle against this tender/work.
	2	The vehicle should have all types of permits required by the Government bodies so that the vehicle can be used for this work.
	3	The vehicles shall not be older than the MENTIONED IN BID from the date of opening of this tender and must be in very good condition externally/internally, free from any history of accident.
	4	The vehicle shall have to be presented to concerned authority for inspection for physical condition, appearance, etc and prior approval to be taken before commencement of the work.
	5	The vehicle should have valid insurance and pollution under control certificate. These certificates shall be renewed from time to time as per the existing norms of the state government. Railway shall not be responsible for any lapse for any of the point violated, which otherwise the owner of the vehicle is supposed to comply towards the governmental bodies.
	6	Copy of all papers of vehicle registration/comprehensive insurance/driving license of driver etc shall have to be submitted before commencement of service. Railway may ask presentation of original documents for authenticity.
	7	Vehicles should not be owned by Railway Officer/Staff or by their family member.
B		REQUIREMENTS FOR THE DRIVER:
	1	The driver shall have a valid driving license for the vehicle offered.
	2	The driver should not have any criminal background. The police verification certificate regarding this shall be submitted for the driver before deploying him/her to the duties.
	3	The contractor should not change the driver frequently. In case of change of driver, prior police verification certificate shall be submitted for the newer one.
	4	The driver should not be alcoholic. If the driver is found drunk on duty he shall be sent immediately back and the absent shall be marked for the day and penalty shall be imposed as per GEM SLA.
	5	The contractor shall ensure that all the drivers deployed should have live mobile phone so that they can be contacted anytime whenever required.
	6	Driver shall be educated enough to know about navigation through google map.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 9. Creating bid for items from incorrect categories.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
