4. 1. Special Terms and Conditions for Fabricated Special Purpose Vehicle on Truck/Van

Note for Buyers :

1. This category is designated for the procurement of vehicles fabricated on truck or van chassis. Buyers must select the specific application from the available options under the "Application of Vehicle" parameter.
2. The category is "BID ONLY" and procurement will occur exclusively through the bidding process.
3. Buyers must specify in the bid whether the base vehicle will be provided by them or the seller.
4. If the base vehicle is provided by the buyer, details such as vehicle category, chassis type, fuel type, axle configuration, and other relevant specifications must be included in the bid.
5. Buyers must also provide comprehensive details on fabrication, equipment, and accessories as part of the bid.

Note for Sellers :

- o For listing a catalog on GeM, the seller can provide an average reference price depending on the selections made. As the category is bid-only, the seller can submit their offer price while participating in the bid, based on the scope of work provided by the buyer.
- o The seller may upload a reference image for the type of vehicle selected under "Application of Vehicle" parameter.

In case of bunch bids, the primary product having highest value should meet this criterion.

4. **Turnover**

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. The project involves modification / fabrication of bus shell on the chassis Eicher 2090L CNG ESC CWC AC (to be supplied by the buyer organization) including driver cabin partition duly air conditioned with vehicle run AC as per specification including (1) floor runner made up of using 75 x 40 mm channel, super structure fabrication will be done using MS square tube of size 40 x 40 x 1.6 mm and 25 x 25 x 1.6 mm; (2) all side panelling will be done using G.I. sheet, front and rear design using windshield glass. Automotive glass on both sides as per design. General lay out/ design of the proposed bus is given on Annexure -1 of the Buyer Added Bid Specific ATC Document (pdf file).

2. Payment shall be made in two stages as per UP Govt./ University rules: -

(1) 80% of the Contract Value shall be released upon successful delivery, inspection, and acceptance of the vehicle at MMMUT Gorakhpur, duly certified by the

Dean, EOFAR, and the Officer-in-Charge (Vehicle). The release shall be subject to the issuance of Form 22-A (Part-II) and 22-B by the body manufacturer and the registration of the vehicle with the RTO, Gorakhpur, Uttar Pradesh.

(2) Balance 20% of the Contract Value shall be released within 15 days after submission and acceptance of the Satisfactory Functioning Report jointly issued by Dean, EOFAR and Officer In Charge, Vehicle confirming that the vehicle is functioning satisfactorily and is free from any visible defects.

No payment shall be made in advance. Payments are subject to statutory deductions, if any, as per applicable Government rules.

3. The University reserves the right to cancel/ reject any bid without assigning any reason thereof. No communication shall be entertained in this regard.

4. The competent authority of the University reserves all rights to extend the due date or cancel or modify the terms and conditions, specifications of the bid etc., if so required.

5. In case of any dispute, a person nominated by Hon'ble Vice Chancellor, MMM UT will be the sole arbitrator.

6. Deduction of T.D.S will be done as per Government rules.

7. All disputes are subject to Jurisdiction of Gorakhpur court only.

8. The bidder shall quote as per detailed specifications given in the Bid document at the designated site at MMMUT, Gorakhpur. The quoted rate shall include all taxes, duties, charges etc.

9. The bidder must enclose an undertaking on its letterhead stating that the bidder has not been blacklisted by any institution of the Central/ State /PSU/ University/ Institute etc. in the past three years.

10. Exemption from EMD is permitted as per GeM GTC.

11. The bidder should have GST Registration, and the GST number should be active. A copy of GST Registration Certificate should be uploaded with the bid. The bidder should upload a copy of his/her PAN Card.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
