1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. 4. **1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Turnover**

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

**3. Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

**4. Buyer Added Bid Specific ATC**

1 License: The bidder must upload a valid Drug License issued by the competent authority.

2. Registration in Karnataka: The bidder's company must be registered within the jurisdiction of Karnataka. Supporting documents must be uploaded in the bid; failure to do so will result in bid rejection.

3. Turnover Certificate: The bidder must submit a Turnover Certificate issued by a Chartered Accountant.

4. Income Tax Returns (ITR): Copies of Income Tax Returns for the last three financial years must be submitted.

5. The rate should be quoted for all the Items.

6. Catalogue Submission: The bidder must include a catalogue for the primary item as a part of the bid document. This is a bunch bid, and bidders must refer to the specific

ations and list of items to be procured.

7. Financial Documents: The bidder must upload financial documents with a detailed breakdown of rates.

8. Specification Compliance: The bidder must comply with the specifications and the Bill of Quantities (BOQ).

9. Satisfactory Performance Certificates: The bidder must provide satisfactory performance certificates from government, semi-government, or institutional clients.

10. GST Certification: A valid GST certification issued by the relevant authority must be submitted.

11. Compliance with BOQ and Specifications: The bidder must adhere to the BOQ and product specifications mentioned in the tender.

12. GST Returns: The bidder must upload GST (3B) returns for the last six months.

13. Tender Evaluation Authority Rights: The Tender Verification Team reserves the right to approve or reject any bid at its discretion.

14. Submission of Hard Copies: Bidders must submit hard copies of the bid documents, along with all supporting documents and samples, to the designated office before the due date. Late submissions will be summarily rejected.

15. Certificate regarding Not black listed by any government department.

16. Pan Card

17. If bidder is authorized dealer, authorization letter from Manufacturer Company is compulsory. Original Authority letter on company letterhead with seal and stamp must be submitted

18. ISO/WHO/FFS/CE/ISI/GMP/BIS whichever applicable should be attached

19. All samples of all the mentioned in bid (quoted product) should be submitted to District Surgeon Office, District Hospital Dharwad within the bid end date for evaluating the samples as it requires for patient care services. and Sample submitted to office copy should be uploaded. Failing to submit the copy, bid will be rejected.

20. Self Declaration regarding bidder or bidders relatives is not working in Health Department on Permanent or Contract basis

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
