No other software provides the same level of compatibility with our existing drawings and project data, which are already prepared in AutoCAD format. The software is essential for preparing accurate technical drawings, plans, layouts, and design modifications required for official and project-related work. Purchasing AutoCAD through PAC bid on GeM ensures procurement of genuine licensed software from an authorized seller while maintaining transparency and compliance with government procurement guidelines. This purchase will improve work efficiency, reduce drafting errors, and help in timely completion of technical and engineering tasks. Therefore, procurement of AutoCAD software through PAC bid is justified and necessary. AutoCAD software is proposed to be purchased through GeM via PAC (Proprietary Article Certificate) bid because it is a specialized and proprietary software developed by Autodesk, and no equivalent alternative software provides the same compatibility, accuracy, and industry-standard features. Our office requires AutoCAD for preparing technical drawings, layouts, and engineering designs in a standardized format. Existing project files and drawings are already prepared in AutoCAD format, making it necessary to maintain continuity and avoid compatibility issues. Procurement through PAC bid on GeM ensures transparency and compliance with government procurement rules while allowing us to obtain genuine licensed software from an authorized source.</p>

1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity

during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
