Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. 4. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

1. Project Experience & Turnover Criteria :

1] The Bidder must have successfully executed /completed similar services over the last 3 years i.e. the current financial year and the last 3 financial years as per following i.e. one single order of 80% value of the bid or 2 orders each of 50% value of the bid or 3 orders each of 40% value of the bid for similar services in last three years to any Central/State Govt. Organization/PSU/Public Listed Company.

2] The minimum average annual financial turnover of the bidder during last 3 financial year , ending on 31st March of previous financial year, should be as indicated above in the bid document

3] The Documentary evidence in the form of certified audited balance sheet(in a separate page/sheet) for relevant period or a certificate from chartered accountant /cost accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of Constitution/incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for these criteria.

2. Other Terms and conditions :

1] Firms which are having status “**SUSPENDED**” within last 1 year of generation of Bid in GeM portal, the firms will not be considered for technical evaluation. The Seller has to submit self-certification regarding the same along with technical bid. Format is enclosed along with Bid.

2] The Seller has to comply and execute the work as per scope of work (Annexure A) & GeM Service level agreement for Service Category Manpower Outsource Service -Minimum Wages and its amendments issued from time to time.

3] PAYMENT OF SALARIES AND WAGES : Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer along with all statutory documents like , PF, ESIC etc. as well as the bank statement of payment done to staff.

4] The offers of Sellers who are on watch listed status will not be accepted at the time of technical evaluation. Also all watch listed sellers will be excluded while RUN L1 selection by the system.

5] The Minimum Wages will be amended as per change in minimum wages as notified by Ministry of Labour time to time and no separate TPC will be held for the same.

6] Availability of Office of Service Provider:-The Service Provider should have a registered office/company in Maharashtra Region. The service provider has to att

ach the Shop/Office Licence certificate issued by Govt. Authorities along with Technical Bid without the proof as above will be technically disqualified. Documents like Rent Agreement with Individuals/Company for flat/Office etc. will not be treated as proof for registered office.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
