#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

A). TECHNICAL ELIGIBILITY CRITERIA As a proof of technical experience/competence,

the tenderer should have physically completed successfully at least one \*similar single work for a minimum value of 35% of advertised tender value, in last three financial years (i.e. Current year and three previous years) up to the date of opening of the tender. Completed Service contract includes on-going service contract subject to payment of bills amounting to at least 35% of the advertised value of bid.

\*DEFINITION OF SIMILAR WORK:

Additionally, the bidder shall be an Original Equipment Manufacturer (OEM) or an authorised representative of the respective OEM(s), Where an authorised agent/representative submits a bid on behalf of an OEM, the same agent/representative shall not submit a bid on behalf of another OEM for the same item/product in the same tender. The bidder shall also submit a valid authorisation letter for the make and model offered.

**B). FINANCIAL ELIGIBILITY CRITERIA:** - The bidder will be qualified only if they have minimum financial capabilities as below:-

1. The Bidder should have an aggregate financial turnover not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year upto the date of opening of the tender. The audited balance sheet reflecting financial turnover certified by chartered accountant with her stamp, signature and membership shall be considered.

2. Liquidity- The bidder should have access to or has available liquid assets, lines of credit and other financial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's commitments for other contracts. The audited balance sheet and/or banking reference certified by chartered accountant with her stamp, signature and membership number shall be submitted by the bidder along with bid. Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the Joint Venture/Consortium. In case the Net current Assets (as seen from the balance sheets) are negative, only the Banking reference will be considered. Otherwise the aggregate of the Net Current Assets and submitted Banking references will be considered for working out the Liquidity. The Banking reference should be from a Schedule Bank in India and it should not be more than 3 months old as on date of submission of bids. In Case of JV firms overall liquidity of JV firm shall be assessed by arithmetic sum of liquidity of all members of JV. C. As per GCC Clause No- 2.6.2.1.2-Each page of the copy of documents/ Certificates in support of credentials submitted by the bidder shall be self attested by the bidder or authorized representative of the bidding firm. Self-attestation shall include signature, stamp and date or Digitally signed by authorized signatory (on each page). Only, those documents will be considered for evaluating bid, which are duly self attested as above.

D. As per GCC Clause No- 2.6.2.1.3 The bidders shall submit an undertaking to the effect that all the documents submitted by her/him along with her bid are true. The offer shall be summarily rejected, if the bidder fails to submit this undertaking along with the bid.

E. Railway board letter No. No./2017/EnHM/25/11 dated 21.12.2023 and Letter No. No.2017/EnHM/25/11 dated 01.07.2020 will be applicable.

F. Bidder must submit Annexure A,B and C attached in Buyer added bid specific ATC.

G. Bidder must submit OEM authorization of each item placed at S.No 2,4,5 and 6 of scope of work.

OFFERS WITHOUT CONFORMING TO THE ABOVE ELIGIBILITY CRITERIA AS ENUMERATED IN CLAUSES A, B , C , D , E ,F & G ABOVE SHALL BE TREATED AS INELIGIBLE AND SUMMARILY REJECTED.

Other Terms and conditions

1. Firm must submit the Bank Guarantee as Security Deposit/EPBG within 15 Days of placement of GEM contract.

2. BG/DD/FDR/TDR must be submitted in the office of Sr.DMM/DLI (State Entry Road /DRM office /New Delhi).

3. Firm should submit proper detail of EMD transaction (UTR Reference number , Account Number, IFSC code, Bank address with GST to avoid any delay in releasing of EMD.
