2. For Engagement of Skilled & Unskilled Manpower

Income Tax Department (Through GeM Portal)**

1. Scope of Work

The service provider shall supply Skilled, Semi-Skilled and Unskilled manpower for various offices under the Income Tax Department.

Indicative nature of duties:

Data Entry Operator, MTS, Office Assistant

Peon, Messenger, Dak Runner

Computer Operator, Technical Helper

Any other similar work as assigned

Duties may include:

Office work

Record management

The deployed manpower shall work under the supervision of officers of the Income Tax Department, but shall remain employees of the service provider only.

2. Period of Contract

The contract shall initially be for one year from the date of commencement.

The contract may be extended annually based on:

The Department reserves the right to terminate the contract at any time by giving one month's notice or payment in lieu thereof, without assigning any reason.

3. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. **DOCUMENTARY EVIDENCE TO BE SUBMITTED.**

4. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

5. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

7. Floating / creation of work contracts as Custom Bids in Services.
