4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

9. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

If the buyer has mentioned MSE purchase preference in ATC then service provider is required to upload necessary documents for MSE purchase preference for verification by the buyer during evaluation.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

2. Buyer Added Bid Specific ATC

- iii. Firm must have executed at least one supply order of minimum 80% of the estimated value, or two supply order of 50% of the estimated value or three supply order of 40% of estimated value for providing similar service to any Central Government/State Government or Public Sector Undertaking in the last 03 years. Relevant documents i.e. copy of Contract Order and Execution Certificate/Job Completion Certificate are to be uploaded by the bidder along with bid. (MSEs & Startups are exempted).
- iv. Average annual turnover of the bidder for the last 03 years ending on 31st March of preceding year (2025) must be at least 30% of the estimated value of the case rounded off to the nearest lakh i.e. Rs. 126 lakhs. Bidders shall submit Certificate from registered CA indicating the turnover details for last 3 years (2022-23, 2023-24 & 2024-25) along with bid in support of financial capability. (MSEs & Startups are exempted).
- v. Bidders have to submit latest copy of registration certificates of MSME for EMD exemption.
- vi. Bidders have to submit the GST certificate along with bid.
- vii. Firm has to comply with all security norms and procedures applicable at designated disposal ground/site.
- viii. **Vendor Eligibility Criteria:**
 - i. The firm should have ammunition technical officers retired from army / similarly place officers of other armed forces.
OR
Personnel with possession of explosive license or other similar certification in handling and disposal of ammunition and explosive from competent authority.
 - j. If the ammunition or explosive is disposed off at the demilitarization plant by the firm, the firm will have to ensure the plant is having the No Objection Certificate from Pollution control Board.
 - k. The firm should have skilled manpower with demonstrated expertise in explosive handling, preferably employing ex-serviceman or certified personnel.
 - l. The firm should have the past experience in collaboration with government and other private explosive manufacturing industries for the disposal / demolition activities.
- xiii. Bidders has to comply any other term & condition as mentioned in scope of

work and submit the sealed signed copy of scope of work, if the bidder does not submit the same their offer will be rejected.

xiv. **Payment terms- 100% Payment will be made within 30 days on successful job completion by firm supported by documentary evidence by user section.**

xv. **Price Variation Clause-Not Applicable Price of the Contract will be firm & fixed being a whole job and no escalation in the contract value shall be entertained.**

xvi. **Penalty clause as per GeM.**

xvii. **Option Clause** - The buyer reserves the right to increase/decrease the quantity up to 50% at the time of placement of contract. The buyer also reserves the right to increase the ordered quantity by up to 50% of the contract quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

xviii. Quantity mentioned in terms & conditions may vary.
