Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. **23. CONFLICT OF INTEREST AMONG BIDDERS / AGENTS**

**Treatment of cases regarding conflict of interest:**

The bidder notes that a conflict of interest would said to have occurred in the tender process and execution of the resultant contract, in case of any of the following situations:

i) If its personnel have a close personal, financial, or business relationship with any personnel of BHEL who are directly or indirectly related to the procurement or execution process of the contract, which can affect the decision of BHEL directly or indirectly;

ii) The bidder (or his allied firm) provided services for the need assessment/ procurement planning of the Tender process in which it is participating;

iii) Procurement of goods directly from the manufacturers /suppliers shall be preferred. However, if the OEM/ Principal insists on engaging the services of an agent, such agent shall not be allowed to represent more than one manufacturer/ supplier in the same tender. Moreover, either the agent could bid on behalf of the manufacturer/ supplier or the manufacturer/ supplier could bid directly but not both. In case bids are received from both the manufacturer/ supplier and the agent, bid received from the agent shall be ignored. However, this shall not debar more than one Authorised distributor (with/ or without the OEM) from quoting equipment manufactured by an Original Equipment Manufacturer (OEM) in procurements under a Proprietary Article Certificate.

iv) A bidder participates in more than one bid in this tender process. Participation in any capacity by a Bidder (including the participation of a Bidder as a partner/ JV member or sub-contractor in another bid or vice-versa) in more than one bid shall result in the disqualification of all bids in which he is a party. However, this does not limit the participation of an entity as a sub-contractor in more than one bid if he is not bidding independently in his own name or as a member of a JV.

The Bidder declares that they have read and understood the above aspects, and the bidder confirms that such conflict of interest does not exist and undertakes that they will not enter into any illegal or undisclosed agreement or understanding, whether formal or informal with other Bidder(s), in this regard.

This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process. In case, the Bidder is found having indulged in above activities, the same will be considered as a violation of the tender conditions, and suitable action shall be taken by BHEL as per extant policies/ guidelines.

**24. SPECIAL CONDITIONS**

This may be noted that any deviation to GeM tender shall not be entertained as buyer can't modify any t

ender terms after bid submission or offline settlement of any deviations during Part-1 evaluation is also not possible. **In this regard, kindly note that commercial terms such as Quantity, Offer Validity, Inspection, Delivery, Freight, Insurance, Payment, LD, Guarantee/ Warranty or any other terms shall be as per tender only. Hence, submission of additional bidding format or any other document/ Format/ Seller Terms & Conditions shall not be considered in GeM. Sellers are requested not to upload any such extra documents. This is for information and compliance, otherwise the offer is liable to be rejected.**

**Bidders who fail to upload declaration against local content at proper place in GeM shall automatically be considered as Non-Local bidder by GeM system and no preference shall be given by GeM functionality.**

**Bidders who fall under MSE (Micro & Small Enterprises only) and fail to upload 'Udyam Registration Certificate (URC)' at proper place in GeM shall automatically be considered as Non-MSE bidder by GeM system and no preference shall be given by GeM functionality.**

In absence of or inability of bidder to upload the relevant documents at proper place in GeM, the GeM system functionally may debar any bidder from availing local bidder benefits or MSE benefits like purchase preference etc. Also, the admissibility of claim of bidder related to these issues cannot be made later once offer is submitted through GeM. **It is totally as per the GeM functionality and in any such event, BHEL has neither any control over the process nor will be held responsible for same.**
