1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**BID REQUIREMENTS.** The bidder shall submit following bid requirements,

1. **Quoting/Offering of Product:** The Bidder shall quote the bid in strict accordance with the list-of-narcotic-detection-kit\_-\_49\_tests attached in the Bid Document.

2. **Manufacturer Authorization Form (MAF):** The Bidder shall submit the Bid Specific Manufacturer Authorization Form (MAF), duly ink-signed with date and place, clearly indicating the bid number and date of bid publication. The MAF shall be verified with the Original Equipment Manufacturer (OEM), and in the event of it appearing to be forged or incorrect, the matter shall be referred to the GeM authority for suspension.

3. **Experience Criteria:** The Bidder shall submit contract copies/purchase orders/supply orders/work orders of Narcotics Detection Kits/similar category products supplied to Central G

overnment/State Government/PSU including Goa Police/Forensic Science Laboratory, Verna -Goa for the last 3 financial years along with: Performance certificate/Work completion certificate/Consignee receipt & acceptance certificate and Invoice generated after acceptance of the product.

**4. Document Authentication:** All documents submitted by the Bidder shall be ink-signed by the Bidder or the Original Equipment Manufacturer (OEM).

**5. Non-Blacklisting Certificate:** The Bidder shall submit a notarized certificate on stamp paper stating that their firm has not been blacklisted by any Central/State Government and is not under liquidation, court receivership, or any proceeding, and has not been declared bankrupt for the last 5 years. Failure to comply may result in bid rejection.

**6. Mandatory Documents:** The Bidder shall submit the following valid documents:

- a. Incorporation/Establishment Certificate of the bidder/OEM
- b. Or MSME Certificate/NSIC Certificate of the bidder

**7. Technical Catalogue and Compliance:** The Bidder shall attach the Technical Catalogue with the Technical Bid.

**8. Fake/Forgery Documents:** Submission of fake/forged documents/certificates will lead to disqualification and blacklisting by the Buyer.

**9. Technical Specifications Compliance :** The Bidder shall submit the compliance of list-of-narcotic-detection-kit\_-\_49\_tests.

**10. Bid Rejection:** Bid is liable to be rejected if required certificates/documents are not uploaded. No clarifications will be sought for non-compliant documents submitted.

**11. Warranty certificate/Validity certificate :** The product must have a 24-month warranty, or the warranty as offered by the OEM. The successful bidder shall submit a Warranty Certificate, Validity Certificate, ATC Compliance, and Bidder's Profile.

**12. Buyer Discretion:** The Buyer reserves the right to cancel the bid/contract at any point in time without prior notice. The buyer reserves the right to relax the conditions/bid requirements as mentioned above.

## 9. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
